- 24 (2) right to issue any type of bond for a purpose for

- 27 (3) right to impose or collect an assessment or tax; or

- 1 (4) legality or operation.
- 2 SECTION 6. FINDINGS OF BENEFIT AND PUBLIC PURPOSE.
- 3 (a) The district is created to serve a public use and benefit. All
- 4 the land and other property included in the district will be
- 5 benefited by the improvements and services to be provided by the
- 6 district under powers conferred by Sections 52 and 52-a, Article
- 7 III, and Section 59, Article XVI, Texas Constitution, and other
- 8 powers granted under this Act.
- 9 (b) The creation of the district is in the public interest
- 10 and is essential to:
- 11 (1) further the public purposes of development and
- 12 diversification of the economy of the state; and
- 13 (2) eliminate unemployment and underemployment and
- 14 develop or expand transportation and commerce.
- 15 (c) The district will:
- 16 (1) promote the health, safety, and general welfare of
- 17 residents, employers, employees, visitors, and consumers in the
- 18 district, and the general public;
- 19 (2) provide needed funding to preserve, maintain, and
- 20 enhance the economic health and vitality of the district as a
- 21 community and business center; and
- 22 (3) further promote the health, safety, welfare, and
- 23 enjoyment of the public by providing pedestrian ways and by
- landscaping and developing certain areas in the district, which are
- 25 necessary for the restoration, preservation, and enhancement of
- 26 scenic beauty.
- 27 (d) Pedestrian ways along or across a street, whether at

- 1 grade or above or below the surface, and street lighting, street
- 2 landscaping, and street art objects are parts of and necessary
- 3 components of a street and are considered to be a street or road
- 4 improvement.
- 5 (e) The district will not act as the agent or
- 6 instrumentality of any private interest even though many private
- 7 interests will be benefited by the district, as well as the general
- 8 public.
- 9 SECTION 7. APPLICATION OF OTHER LAW. (a) Except as
- 10 otherwise provided by this Act, Chapter 375, Local Government Code,
- 11 applies to the district.
- 12 (b) Chapter 311, Government Code, applies to this Act.
- 13 SECTION 8. CONSTRUCTION OF ACT. This Act shall be liberally
- 14 construed in conformity with the findings and purposes stated in
- 15 this Act.
- 16 SECTION 9. BOARD OF DIRECTORS IN GENERAL. (a) The
- district is governed by a board of five voting directors appointed
- 18 under Section 10.
- 19 (b) Voting directors serve staggered terms of four years,
- 20 with three directors' terms expiring June 1 of an odd-numbered year
- 21 and two directors' terms expiring June 1 of the following
- 22 odd-numbered year.
- (c) The board may increase or decrease the number of
- 24 directors on the board by resolution, provided that it is in the
- 25 best interest of the district to do so and that the board consists
- of not fewer than five and not more than 15 directors.
- 27 SECTION 10. APPOINTMENT OF DIRECTORS. The board shall

- 1 nominate a slate of persons to serve as voting directors. The
- 2 members of the governing body of the City of Missouri City shall
- 3 appoint as voting directors the slate of persons nominated by the
- 4 board.
- 5 SECTION 11. CONFLICTS OF INTEREST; ONE-TIME AFFIDAVIT.
- 6 (a) Except as provided by this section:
- 7 (1) a director may participate in all board votes and
- 8 decisions; and
- 9 (2) Chapter 171, Local Government Code, governs
- 10 conflicts of interest for directors.
- 11 (b) Section 171.004, Local Government Code, does not apply
- 12 to the district. A director who has a substantial interest in a
- 13 business or charitable entity that will receive a pecuniary benefit
- 14 from a board action shall file a one-time affidavit declaring the
- 15 interest. An additional affidavit is not required if the
- 16 director's interest changes. After the affidavit is filed with the
- 17 board secretary, the director may participate in a discussion or
- 18 vote on that action if:
- 19 (1) a majority of the directors have a similar
- 20 interest in the same entity; or
- 21 (2) all other similar business or charitable entities
- 22 in the district will receive a similar pecuniary benefit.
- (c) A director who is also an officer or employee of a public
- 24 entity may not participate in the discussion of or vote on a matter
- 25 regarding a contract with that same public entity.
- 26 (d) For purposes of this section, a director has a
- 27 substantial interest in a charitable entity in the same manner that

- 1 a person would have a substantial interest in a business entity
- 2 under Section 171.002, Local Government Code.
- 3 SECTION 12. ADDITIONAL POWERS OF DISTRICT. The district
- 4 may exercise the powers given to:
- 5 (1) a corporation created under Section 4B,
- 6 Development Corporation Act of 1979 (Article 5190.6, Vernon's Texas
- 7 Civil Statutes), including the power to own, operate, acquire,
- 8 construct, lease, improve, and maintain projects described by that
- 9 section; and
- 10 (2) a housing finance corporation created under
- 11 Chapter 394, Local Government Code, to provide housing or
- 12 residential development projects in the district.
- 13 SECTION 13. AGREEMENTS; GRANTS. (a) The district may make
- 14 an agreement with or accept a gift, grant, or loan from any person.
- 15 (b) The implementation of a project is a governmental
- 16 function or service for the purposes of Chapter 791, Government
- 17 Code.
- 18 SECTION 14. LAW ENFORCEMENT SERVICES. To protect the
- 19 public interest, the district may contract with Fort Bend County or
- 20 the City of Missouri City to provide law enforcement services in the
- 21 district for a fee.
- 22 SECTION 15. NONPROFIT CORPORATION. (a) The board by
- 23 resolution may authorize the creation of a nonprofit corporation to
- 24 assist and act on behalf of the district in implementing a project
- or providing a service authorized by this Act.
- 26 (b) The board shall appoint the board of directors of a
- 27 nonprofit corporation created under this section. The board of

- 1 directors of the nonprofit corporation shall serve in the same
- 2 manner as the board of directors of a local government corporation
- 3 created under Chapter 431, Transportation Code.
- 4 (c) A nonprofit corporation created under this section has
- 5 the powers of and is considered for purposes of this Act to be a
- 6 local government corporation created under Chapter 431,
- 7 Transportation Code.
- 8 (d) A nonprofit corporation created under this section may
- 9 implement any project and provide any service authorized by this
- 10 Act.
- 11 SECTION 16. REQUIREMENTS FOR FINANCING SERVICES AND
- 12 IMPROVEMENTS. The board may not finance a service or improvement
- 13 project with assessments under this Act unless a written petition
- 14 requesting that improvement or service has been filed with the
- 15 board. The petition must be signed by:
- 16 (1) the owners of a majority of the assessed value of
- 17 real property in the district subject to assessment as determined
- 18 by the most recent certified tax appraisal roll for Fort Bend
- 19 County; or
- 20 (2) at least 25 persons who own real property in the
- 21 district if more than 25 persons own real property in the district
- 22 as determined by the most recent certified tax appraisal roll for
- 23 Fort Bend County.
- SECTION 17. ELECTIONS. (a) The district shall hold an
- 25 election in the manner provided by Subchapter L, Chapter 375, Local
- 26 Government Code, to obtain voter approval before the district
- 27 imposes a maintenance tax or issues a bond payable from ad valorem

- 1 taxes.
- 2 (b) The board may include more than one purpose in a single
- 3 proposition at an election.
- 4 (c) Section 375.243, Local Government Code, does not apply
- 5 to the district.
- 6 SECTION 18. MAINTENANCE TAX. (a) If authorized at an
- 7 election held in accordance with Section 17, the district may
- 8 impose an annual ad valorem tax on taxable property in the district
- 9 for the maintenance and operation of the district and the
- 10 improvements constructed or acquired by the district or for the
- 11 provision of services.
- 12 (b) The board shall determine the tax rate.
- SECTION 19. ASSESSMENTS. (a) The board by resolution may
- impose and collect an assessment for any purpose authorized by this
- 15 Act.
- 16 (b) Assessments, including assessments resulting from an
- 17 addition to or correction of the assessment roll by the district,
- 18 reassessments, penalties and interest on an assessment or
- 19 reassessment, expense of collection, and reasonable attorney's
- 20 fees incurred by the district:
- 21 (1) are a first and prior lien against the property
- 22 assessed;
- 23 (2) are superior to any other lien or claim other than
- 24 a lien or claim for county, school district, or municipal ad valorem
- 25 taxes; and
- 26 (3) are the personal liability of and charge against
- 27 the owners of the property even if the owners are not named in the

- 1 assessment proceedings.
- 2 (c) The lien is effective from the date of the resolution of
- 3 the board imposing the assessment until the date the assessment is
- 4 paid. The board may enforce the lien in the same manner that the
- 5 board may enforce an ad valorem tax lien against real property.
- 6 (d) Without necessity of notice and hearing in the manner
- $7\,$   $\,$  required for additional assessments, the board may make corrections
- 8 to or deletions from the assessment roll, provided that such
- 9 corrections or deletions do not increase the amount of assessment
- 10 of any parcel of land.
- 11 SECTION 20. UTILITIES. The district may not impose an
- impact fee or assessment on the property, equipment, rights-of-way,
- 13 facilities, or improvements of an electric utility or a power
- 14 generation company as defined by Section 31.002, Utilities Code, a
- 15 gas utility as defined by Section 101.003 or 121.001, Utilities
- 16 Code, or a telecommunications provider as defined by Section
- 17 51.002, Utilities Code, or of a person that provides to the public
- 18 cable television or advanced telecommunications services. If the
- 19 district, in the exercise of the powers conferred on it by this Act,
- 20 requires or requests the relocation, rerouting, or removal of
- 21 electric, gas, water, sewer, communications, or other public
- 22 utilities, as defined by Section 31.002, 101.003, 121.001, or
- 23 51.002, Utilities Code, the relocation, rerouting, or removal shall
- 24 be at the sole expense of the district.
- 25 SECTION 21. BONDS. (a) The district may issue bonds or
- other obligations payable in whole or in part from ad valorem taxes,
- 27 assessments, impact fees, revenue, grants, or other money of the

- 1 district, or any combination of those sources of money, to pay for
- 2 any authorized purpose of the district.
- 3 (b) In exercising the district's borrowing power, the
- 4 district may issue a bond or other obligation in the form of a bond,
- 5 note, certificate of participation or other instrument evidencing a
- 6 proportionate interest in payments to be made by the district, or
- 7 other type of obligation.
- 8 SECTION 22. MUNICIPALITY NOT REQUIRED TO PAY DISTRICT
- 9 OBLIGATIONS. Except as provided by Section 375.263, Local
- 10 Government Code, a municipality is not required to pay a bond, note,
- 11 or other obligation of the district.
- 12 SECTION 23. DISBURSEMENTS OR TRANSFERS OF MONEY. The board
- 13 by resolution shall establish the number of directors' signatures
- 14 and the procedure required for a disbursement or transfer of the
- 15 district's money.
- 16 SECTION 24. COMPETITIVE BIDDING LIMIT. Section 375.221,
- 17 Local Government Code, applies to the district only for a contract
- that has a value greater than \$25,000.
- 19 SECTION 25. EXCEPTION FOR DISSOLUTION OF DISTRICT WITH
- 20 OUTSTANDING DEBT. (a) The board may vote to dissolve a district
- 21 that has debt. If the vote is in favor of dissolution, the district
- 22 shall remain in existence solely for the limited purpose of
- 23 discharging its debts. The dissolution is effective when all debts
- 24 have been discharged.
- 25 (b) Section 375.264, Local Government Code, does not apply
- 26 to the district.
- 27 SECTION 26. INITIAL DIRECTORS. (a) The initial board

- 1 consists of the following persons:

- 8 (b) Of the initial directors, the terms of directors 9 appointed for positions 1 through 3 expire June 1, 2007, and the
- terms of directors appointed for positions 4 and 5 expire June 1,
- 11 2005.
- 12 (c) Section 10 does not apply to this section.
- 13 (d) This section expires September 1, 2007.
- 14 SECTION 27. TAX AND ASSESSMENT ABATEMENTS. Without further
- 15 authorization or other procedural requirement, the district may
- 16 grant, consistent with Chapter 312, Tax Code, an abatement for a tax
- 17 or assessment owed to the district.
- 18 SECTION 28. MEMBERSHIP IN CHARITABLE ORGANIZATIONS. The
- 19 district may join and pay dues to an organization that enjoys
- 20 tax-exempt status under Section 501(c)(3), (4), or (6), Internal
- 21 Revenue Code of 1986, as amended, and perform services or provide
- 22 activities consistent with the furtherance of the purposes of the
- 23 district. An expenditure of public money for membership in the
- 24 organization is considered to further the purposes of the district
- and to be for a public purpose.
- 26 SECTION 29. ELIGIBILITY FOR INCLUSION IN SPECIAL ZONES.
- 27 All or any part of the area of the district is eligible,

- 1 notwithstanding other statutory criteria, to be included in a tax
- 2 increment reinvestment zone created by the municipality under
- 3 Chapter 311, Tax Code, or included in a tax abatement reinvestment
- 4 zone created by the municipality under Chapter 312, Tax Code. All
- 5 or any part of the area of the district is also eligible to be
- 6 included in an enterprise zone created by the municipality under
- 7 Chapter 2303, Government Code.
- 8 SECTION 30. ECONOMIC DEVELOPMENT PROGRAMS. The district
- 9 may establish and provide for the administration of one or more
- 10 programs, including programs for making loans and grants of public
- 11 money and providing personnel and services of the district, to
- 12 promote state or local economic development and to stimulate
- 13 business and commercial activity in the district. The district has
- 14 all of the powers and authority of a municipality under Chapter 380,
- 15 Local Government Code.
- 16 SECTION 31. LEGISLATIVE FINDINGS. The legislature finds
- 17 that:
- 18 (1) proper and legal notice of the intention to
- 19 introduce this Act, setting forth the general substance of this
- 20 Act, has been published as provided by law, and the notice and a
- 21 copy of this Act have been furnished to all persons, agencies,
- officials, or entities to which they are required to be furnished by
- 23 the constitution and laws of this state, including the governor,
- 24 who has submitted the notice and Act to the Texas Commission on
- 25 Environmental Quality;
- 26 (2) the Texas Commission on Environmental Quality has
- 27 filed its recommendations relating to this Act with the governor,

- 1 lieutenant governor, and speaker of the house of representatives
- 2 within the required time;
- 3 (3) the general law relating to consent by political
- 4 subdivisions to the creation of districts with conservation,
- 5 reclamation, and road powers and the inclusion of land in those
- 6 districts has been complied with; and
- 7 (4) all requirements of the constitution and laws of
- 8 this state and the rules and procedures of the legislature with
- 9 respect to the notice, introduction, and passage of this Act have
- 10 been fulfilled and accomplished.
- 11 SECTION 32. EFFECTIVE DATE. This Act takes effect
- immediately if it receives a vote of two-thirds of all the members
- elected to each house, as provided by Section 39, Article III, Texas
- 14 Constitution. If this Act does not receive the vote necessary for
- immediate effect, this Act takes effect September 1, 2003.
