- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. CREATION OF DISTRICT. (a) Harris County Road
- 6 Improvement District No. 2 is created as a special district under
- 7 Section 52, Article III, and Section 59, Article XVI, Texas
- 8 Constitution.
- 9 (b) The board by resolution may change the district's name.
- 10 SECTION 2. DECLARATION OF INTENT. (a) The creation of the
- 11 district is necessary to promote, develop, encourage, and maintain
- 12 transportation, safety, employment, commerce, housing, tourism,

- SECTION 7. APPLICATION OF OTHER LAW. Chapter 311, Government Code (Code Construction Act), applies to this Act.

- 1 SECTION 8. CONSTRUCTION OF ACT. (a) This Act shall be
- 2 liberally construed in conformity with the findings and purposes
- 3 set forth in this Act.
- 4 (b) If any provision of the general law conflicts with this
- 5 Act, this Act prevails.
- 6 SECTION 9. BOARD OF DIRECTORS; TERMS. (a) The district is
- 7 governed by a board of five elected directors who serve staggered
- 8 terms of four years.
- 9 (b) Elections for directors shall be held on the uniform
- 10 election date in May in even-numbered years.
- 11 SECTION 10. QUALIFICATIONS. (a) A person must meet the
- 12 qualifications of Section 375.063, Local Government Code, to serve
- 13 as a director of the district.
- 14 (b) Section 49.052, Water Code, does not apply to directors
- 15 of the district.
- 16 SECTION 11. POWERS OF DISTRICT. The district has all powers
- 17 and authority provided by the general laws on road districts and
- 18 road utility districts created under Section 52, Article III, Texas
- 19 Constitution, and conservation and reclamation districts and
- 20 municipal management districts created under Section 59, Article
- 21 XVI, Texas Constitution, including:
- 22 (1) Chapters 257 and 441, Transportation Code;
- 23 (2) Chapter 375, Local Government Code; and
- 24 (3) Chapters 54 and 49, Water Code.
- 25 SECTION 12. AGREEMENTS; GRANTS. (a) The district may make
- 26 an agreement with or accept a gift, grant, or loan from any person.
- 27 (b) The implementation of a project is a governmental

- 1 function or service for the purposes of Chapter 791, Government
- 2 Code.
- 3 SECTION 13. LAW ENFORCEMENT SERVICES. To protect the
- 4 public interest, the district may contract with a municipality or
- 5 county to provide law enforcement services in the district for a
- 6 fee.
- 7 SECTION 14. AUTHORITY TO IMPOSE AD VALOREM TAXES,
- 8 ASSESSMENTS, AND IMPACT FEES. The district may impose an ad valorem
- 9 tax, assessment, or impact fee and use the proceeds of the tax,
- 10 assessment, or impact fee for any district purpose, including the
- 11 payment of debt or other contractual obligations, or the payment of
- 12 maintenance and operating expenses.
- 13 SECTION 15. ELECTIONS REGARDING TAXES OR BONDS. (a) The
- 14 district must hold an election in the manner provided by Chapters 54
- and 49, Water Code, to obtain voter approval before the district may
- 16 impose a maintenance tax or issue bonds payable from ad valorem
- 17 taxes.
- 18 (b) The board may include more than one purpose in a single
- 19 proposition at an election.
- 20 SECTION 16. MAINTENANCE TAX. (a) The district may impose
- 21 an annual ad valorem tax on taxable property in the district for any
- 22 district purpose, including to:
- 23 (1) maintain and operate the district and the
- 24 improvements constructed or acquired by the district; or
- 25 (2) provide a service.
- 26 (b) The board shall determine the tax rate.
- 27 SECTION 17. ASSESSMENTS; PETITION REQUIRED FOR FINANCING

- 1 SERVICES AND IMPROVEMENTS. (a) The board by resolution may impose
- 2 and collect an assessment for any purpose authorized by this Act.
- 3 (b) The board may not finance a service or improvement
- 4 project through an assessment under this Act unless a written
- 5 petition requesting that service or improvement has been filed with
- 6 the board. The petition must be signed by:
- 7 (1) the owners of a majority of the assessed value of
- 8 real property in the district that will be subject to the assessment
- 9 according to the most recent certified tax appraisal roll for the
- 10 county in which the property is located; or
- 11 (2) at least 25 owners of land in the district that
- 12 will be subject to the assessment, if more than 25 persons own land
- in the district that will be subject to the assessment according to
- 14 the most recent certified tax appraisal roll for the county in which
- 15 the property is located.
- 16 (c) An assessment, a reassessment, or an assessment
- 17 resulting from an addition to or correction of the assessment roll
- 18 by the district, penalties and interest on an assessment or
- 19 reassessment, an expense of collection, and reasonable attorney's
- 20 fees incurred by the district:
- 21 (1) are a first and prior lien against the property
- 22 assessed;
- 23 (2) are superior to any other lien or claim other than
- 24 a lien or claim for county, school district, or municipal ad valorem
- 25 taxes; and
- 26 (3) are the personal liability of and charge against
- 27 the owners of the property even if the owners are not named in the

- 2 (d) The lien is effective from the date of the board's 3 resolution imposing the assessment until the date the assessment is 4 paid. The board may enforce the lien in the same manner that the 5 board may enforce an ad valorem tax lien against real property.
- SECTION 18. OBLIGATIONS. (a) The district may issue bonds or other obligations payable in whole or in part from ad valorem taxes, assessments, impact fees, revenue, grants, or other money of the district, or any combination of those sources of money, to pay

for any authorized purpose of the district.

- 11 (b) In exercising the district's borrowing power, the 12 district may issue a bond or other obligation in the form of a bond, 13 note, certificate of participation or other instrument evidencing a 14 proportionate interest in payments to be made by the district, or 15 other type of obligation.
- SECTION 19. INITIAL DIRECTORS. (a) The initial board consists of the following persons:

(b) Of the initial directors, the terms of the first three directors named in Subsection (a) expire on June 1, 2006, and the terms of the last two directors named in Subsection (a) expire on June 1, 2004.

- 1 (c) On the uniform election date in May 2004, the board
- 2 shall hold an election for the directors whose terms expire on June
- 3 1, 2004. On the uniform election date in May 2006, the board shall
- 4 hold an election for the directors whose terms expire on June 1,
- 5 2006.
- 6 (d) This section expires September 1, 2006.
- 7 SECTION 20. ADDITIONAL LEGISLATIVE FINDINGS. The
- 8 legislature finds that:
- 9 (1) proper and legal notice of the intention to
- 10 introduce this Act, setting forth the general substance of this
- 11 Act, has been published as provided by law, and the notice and a
- 12 copy of this Act have been furnished to all persons, agencies,
- officials, or entities to which they are required to be furnished by
- 14 the constitution and laws of this state, including the governor,
- 15 who has submitted the notice and Act to the Texas Commission on
- 16 Environmental Quality;
- 17 (2) the Texas Commission on Environmental Quality has
- 18 filed its recommendations relating to this Act with the governor,
- 19 lieutenant governor, and speaker of the house of representatives
- 20 within the required time;
- 21 (3) the general law relating to consent by political
- 22 subdivisions to the creation of districts with conservation,
- 23 reclamation, and road powers and the inclusion of land in those
- 24 districts has been complied with; and
- 25 (4) all requirements of the constitution and laws of
- 26 this state and the rules and procedures of the legislature with
- 27 respect to the notice, introduction, and passage of this Act have

- been fulfilled and accomplished.
- 2 SECTION 21. EFFECTIVE DATE. This Act takes effect
- 3 immediately if it receives a vote of two-thirds of all the members
- 4 elected to each house, as provided by Section 39, Article III, Texas
- 5 Constitution. If this Act does not receive the vote necessary for
- 6 immediate effect, this Act takes effect September 1, 2003.
