A BILL TO BE ENTITLED

- 2 relating to the regulation of alarm systems and alarm systems 3 companies.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 214.194, Local Government Code, is 6 amended to read as follows:
- Sec. 214.194. FEE FOR MUNICIPAL PERMIT. If a municipality adopts an ordinance that requires a person to pay an annual fee to obtain a permit from the municipality before the person may use an alarm system in the municipality, the fee may not exceed the rate of:
- 12 (1) \$50 a year for a residential location; or
- 13 (2) \$100 a year for a commercial location.
- SECTION 2. Section 214.195, Local Government Code, is
- amended by amending Subsections (a) and (d) and adding Subsections
- 16 (e) and (f) to read as follows:
- 17 (a) Except as provided in Subsection (e) [(d) of this
- 18 section], a municipality may not terminate its law enforcement
- 19 response to a residential or commercial location [permit holder
- 20 because of excess false alarms if the false alarm fees are paid in
- 21 full].
- 22 (d) A municipality may revoke a permit or [set standards for
- 23 systems to be permitted and may refuse to permit particular
- 24 systems that have had eight or more false alarms during the

- 1 preceding 12-month period [which in its discretion have a history
- 2 of unreliability].
- 3 (e) A municipality that requires an alarm system permit may
- 4 terminate its law enforcement response to a residential or
- 5 commercial location if a permit has not been obtained for that
- 6 property or if the permit is revoked or refused under Subsection
- 7 <u>(d)</u>.
- 8 (f) A municipality that does not respond to the signaling of
- 9 an alarm as described under Subsection (e) is not liable for damages
- 10 that may occur relating to the cause of the alarm system signal.
- 11 SECTION 3. Section 214.197, Local Government Code, is
- 12 amended to read as follows:
- 13 Sec. 214.197. PENALTIES FOR FALSE ALARMS [PENALTY
- 14 **LIMITATIONS**]. [(a)] A municipality may [not] impose a penalty [or
- 15 fee] for the signaling of a false alarm by a burglar alarm system if
- 16 [unless] at least three [five] other false alarms have occurred
- during the preceding 12-month period. The amount of the penalty for
- 18 the signaling of a false alarm as described by Section 214.196 may
- 19 not exceed:
- 20 (1) \$50, if the location has had more than three but
- 21 fewer than six other false alarms in the preceding 12-month period;
- 22 (2) \$75, if the location has had more than five but
- 23 fewer than eight other false alarms in the preceding 12-month
- 24 period; or
- 25 (3) \$100, if the location has had eight or more other
- 26 false alarms in the preceding 12-month period.
- 27 [(b) A penalty or fee imposed for a false alarm must be

- 1 established by ordinance based on the type and level of emergency
- 2 response provided. This fee may not exceed \$50 in the case of the
- 3 category of burglar alarms. The penalty or fee for a false alarm
- 4 may not exceed the actual expenses incurred for the response.
- 5 SECTION 4. Subchapter F, Chapter 214, Local Government
- 6 Code, is amended by adding Section 214.198 to read as follows:
- 7 Sec. 214.198. VERIFICATION. A municipality may require an
- 8 alarm systems monitor to attempt contact with the occupant of the
- 9 <u>alarm system location twice before the municipality responds to the</u>
- 10 <u>alarm system signal.</u>
- 11 SECTION 5. Subchapter L, Chapter 1702, Occupations Code, is
- 12 amended by adding Section 1702.286 to read as follows:
- Sec. 1702.286. DUTIES OF ALARM SYSTEMS COMPANY. (a) On the
- 14 installation or activation of an alarm system, an alarm systems
- 15 company shall distribute to the occupant of the alarm system
- 16 <u>location information summarizing:</u>
- 17 (1) the applicable law relating to false alarms,
- including the potential for penalties and revocation or suspension
- 19 of a permit;

- (2) how to prevent false alarms; and
- 21 (3) how to operate the alarm system.
- (b) An alarm systems company shall notify the municipality
- 23 <u>in which the alarm system is located of an installation or</u>
- 24 activation of an alarm system not later than the 30th day after the
- 25 <u>date of the installation or activation. The alarm systems company</u>
- 26 shall provide to the municipality:
- 27 (1) the alarm systems company name;
