1-11 relating to the application of the professional prosecutors law to
1-12 the district attorney for the 258th Judicial District.

1-13 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-14 SECTION 1. Section 46.002, Government Code, is amended to
1-15 read as follows:

1-16 Sec. 46.002. PROSECUTORS SUBJECT TO CHAPTER. This chapter
1-17 applies to all county prosecutors and to the following state
1-18 prosecutors:

1-19 (1) the district attorneys for the 1st, 2nd, 8th, 9th,
1-20 12th, 18th, 21st, 23rd, 26th, 27th, 29th, 31st, 32nd, 33rd, 34th,
1-21 35th, 36th, 38th, 43rd, 47th, 49th, 50th, 51st, 52nd, 53rd, 63rd,
1-22 64th, 66th, 69th, 70th, 76th, 81st, 83rd, 84th, 85th, 88th, 90th,
1-23 97th, 100th, 105th, 106th, 110th, 118th, 119th, 123rd, 142nd,
1-24 145th, 156th, 159th, 173rd, 196th, 198th, 216th, 220th, 229th,
1-25 235th, 253rd, 258th, 259th, 266th, 268th, 271st, 278th, 286th,
1-26 329th, 349th, and 355th judicial districts;

1-27 (2) the criminal district attorneys for the counties
1-28 of Anderson, Austin, Bastrop, Bexar, Bowie, Brazoria, Caldwell,
1-29 Calhoun, Cass, Collin, Comal, Dallas, Deaf Smith, Denton, Eastland,
1-30 Galveston, Gregg, Harrison, Hays, Hidalgo, Jasper, Jefferson,
1-31 Kaufman, Lubbock, McLennan, Madison, Navarro, Newton, Panola,
1-32 Polk, Randall, Rockwall, San Jacinto, Smith, Tarrant, Taylor,
1-33 Tyler, Upshur, Van Zandt, Victoria, Walker, Waller, Wichita, Wood,
1-34 and Yoakum; and

1-35 (3) the county attorneys performing the duties of
1-36 district attorneys in the counties of Andrews, Callahan, Cameron,
1-37 Castro, Colorado, Crosby, Ellis, Falls, Fannin, Freestone,
1-38 Grayson, Lamar, Lamb, Lampasas, Lee, Limestone, Marion, Milam,
1-39 Morris, Ochiltree, Orange, Rains, Red River, Robertson, Rusk,
1-40 Terry, Webb, and Willacy.

1-41 SECTION 2. This Act takes effect January 1, 2004, and
1-42 applies only to a person elected or appointed to the office of
1-43 district attorney for the 258th Judicial District on or after that
1-44 date.
