WHEREAS, He was a man of integrity, strength, and generosity who gave unselfishly of his time to others, and his wisdom, warmth, and valued counsel will not be forgotten by those who knew him; and

WHEREAS, A devout Christian, Tony was a member of Travis Park United Methodist Church, where he was actively involved in music ministry; and
