- SECTION 5. There is hereby appropriated to the respective
- 19 institutions of higher education \$108,000,000 in General Revenue
- 20 for the 2006-07 biennium for the purpose of paying debt service on
- 21 the bonds authorized by this Act. The debt service appropriations
- 22 shall be transferred to affected institutions of higher education
- 23 based on a plan developed by the Texas Higher Education
- 24 Coordinating Board and approved by the Legislative Budget Board.
- 25 SECTION 6. (a) Except as provided by Subsection (b), this
- 26 Act takes effect immediately if it receives a vote of two-thirds of
- 27 all the members elected to each house, as provided by Section 39,

- 4 (b) Section 4 of this Act takes effect September 1, 2005, if
- 5 this Act receives a vote of two-thirds of all the members elected to
- 6 each house, as provided by Section 39, Article III, Texas
- 7 Constitution. If this Act does not receive that vote, Section 4 of
- 8 this Act takes effect on the 91st day after the last day of the
- 9 legislative session.
