2 were greatly saddened by his death on June 30, 2005, at the age of  
3 82, and we join them in mourning his passing; and

4           WHEREAS, A native of Alberta, Canada, Mr. Viney served in the  
5 Royal Canadian Air Force during World War II before coming to the  
6 United States to study; and

7           WHEREAS, This accomplished professional's great love of  
8 learning was reflected in his lifelong pursuit of academic  
9 excellence, and after receiving a bachelor's degree in petroleum  
10 refining from Tulsa University in 1948, he went on to earn an MBA  
11 from Texas Christian University in 1960 and an associate's degree  
12 in environmental engineering from Midland College in 1998; and

13           WHEREAS, Mr. Viney worked as an engineer in Texas City,  
14 Houston, Fort Worth, and Paterson, New Jersey, before settling in  
15 Midland in 1961 to establish himself as an independent engineering  
16 consultant and oil and gas operator, and since that time he had been  
17 a valued member of the community; and

18           WHEREAS, An avid musician, he delighted friends and family  
19 with his piano and accordion playing, and gave generously of his  
20 talent in his role as music master for the Rotary Club of Midland;

22           WHEREAS, Although Ralph Viney will long be missed, this  
23 esteemed man leaves behind a legacy to treasure for those who held  
24 him dear; now, therefore, be it

2 1st Called Session, hereby pay tribute to the life of Ralph H. Viney  
3 and extend sincere sympathy to the members of his family: to his
