3 in an array of worthy religious and civic organizations; and

4           WHEREAS, Currently serving as senior vice president of The  
5 Urban Alternative, Dr. Evans has held numerous executive management  
6 positions with that organization and remains committed to its  
7 mandate of promoting spiritual growth and renewal in America's  
8 urban areas; she also sits on The Urban Alternative Board of  
9 Directors and enjoyed previous employment with the Billy Graham  
10 Evangelistic Association, the Grand Old Gospel Fellowship

21 serving as the first president of the Global Pastors Wives Network;

1 accolades for her outstanding civic and religious contributions,  
2 including the 1995 Good Samaritan Award from Dallas Baptist

5 of Influence; and

6 WHEREAS, A regular contributor to many notable magazines and  
7 newsletters and a published recording artist and author, Dr. Evans  
8 is first and foremost a devoted partner to her husband, Dr. Tony  
9 Evans, and a loving mother and grandmother; her enthusiasm, energy,  
10 and steadfast faith are an inspiration to all who know her, and it  
11 is a privilege to honor her at this time; now, therefore, be it
