A BILL TO BE ENTITLED

1 AN ACT

- 2 relating to responsibilities of certain state agencies concerning
- 3 radioactive substances; imposing fees and surcharges; providing
- 4 administrative and civil penalties.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. Section 401.003, Health and Safety Code, is
- amended by amending Subdivisions (2), (4), (5), (6), and (15) and by
- 8 adding Subdivision (12-a) to read as follows:
- 9 (2) "Board" means the <u>executive commissioner of the</u>
- 10 Health and Human Services Commission [Texas Board of Health].
- 11 (4) "Commission" means the Texas [Natural Resource
- 12 <u>Conservation</u>] Commission on Environmental Quality.
- 13 (5) "Commissioner" means the commissioner of state
- 14 [public] health services.
- 15 (6) "Department" means the [Texas] Department of State
- 16 Health Services or other department designated by the executive
- 17 commissioner of the Health and Human Services Commission.
- 18 <u>(12-a) "Gross receipts" includes, with respect to an</u>
- 19 entity or affiliated members, owners, shareholders, or limited or
- 20 general partners, all receipts from the entity's disposal
- 21 operations in Texas licensed under this chapter including any
- bonus, commission, or similar payment received by the entity from a
- 23 <u>customer</u>, <u>contractor</u>, <u>subcontractor</u>, <u>or other person doing</u>
- 24 business with the entity or affiliated members, owners,

- 1 shareholders, or limited or general partners. This term does not
- 2 <u>include</u> receipts from the entity's operations in Texas, or
- 3 <u>affiliated members</u>, owners, shareholders, or limited or general
- 4 partners, for capital reimbursements, bona fide storage and
- 5 processing, and federal or state taxes or fees on waste received
- 6 uniquely required to meet the specifications of a license or
- 7 contract. The commission may promulgate rules in establishing the
- 8 criteria for determining gross receipts consistent with the
- 9 parameters of this definition.
- 10 (15) "Person affected" means a person who demonstrates
- 11 that the person has suffered or will suffer actual injury or
- 12 economic damage and, if the person is not a local government:
- 13 (A) is a resident of a county, or a county
- 14 adjacent to that county, in which a nuclear or radioactive
- 15 substance [material] is or will be located; or
- 16 (B) is doing business or has a legal interest in
- 17 land in the county or adjacent county.
- SECTION 2. Subsections (a) and (b), Section 401.011, Health
- 19 and Safety Code, are amended to read as follows:
- 20 (a) The department is the Texas Radiation Control Agency.
- 21 The department has jurisdiction over activities and substances
- 22 regulated under this chapter except as provided by Subsection (b)
- 23 and Subchapters E, F, G, and K.
- 24 (b) The commission has jurisdiction to regulate and
- 25 license:
- 26 (1) the disposal of radioactive substances;
- 27 (2) the processing or storage of low-level radioactive

- 1 waste or naturally occurring radioactive material waste received
- 2 from other persons, except oil and gas NORM;
- 3 (3) the recovery or processing of source material in
- 4 <u>accordance with Subchapter G;</u>
- 5 (4) the processing of by-product material as defined
- 6 by Section 401.003(3)(B); and
- 7 <u>(5) sites for the disposal of:</u>
- 8 (A) low-level radioactive waste;
- 9 (B) by-product material; or
- 10 (C) naturally occurring radioactive material
- 11 <u>waste</u> [except by-product material defined by Section
- 12 401.003(3)(B)].
- 13 SECTION 3. Section 401.054, Health and Safety Code, is
- 14 amended to read as follows:
- Sec. 401.054. NOTICE AND HEARING. (a) The department or
- 16 commission shall provide notice and an opportunity for a hearing on
- 17 a matter under its jurisdiction as provided by its formal hearing
- 18 procedures and Chapter 2001, Government Code, unless otherwise
- 19 required by this chapter, on written request of a person affected by
- 20 any of the following procedures:
- 21 (1) the denial, suspension, or revocation by the
- 22 department or commission of a license or registration;
- 23 (2) the determination by the department <u>or commission</u>
- of compliance with or the grant of exemptions from a department or
- 25 commission rule or order; or
- 26 (3) the grant or amendment by the department or
- 27 commission of a specific license.

- The commission may hold a contested case hearing on a 1 (b) 2 license application under this chapter on the commission's determination that a timely written request for a contested case 3 4 hearing was filed by a person affected. The determination of who is a person affected under this chapter is governed exclusively by 5 6 this chapter [This section does not apply to license or registration activities for which other notice and hearing 7 8 procedures are required by this chapter].
- 9 (c) The commission may hold a contested case hearing on an
 10 application for the renewal of or an amendment of a license issued
 11 under this chapter only if a change is being requested that would
 12 constitute a major amendment and a person affected requests the
 13 hearing.
- SECTION 4. Section 401.104, Health and Safety Code, is amended by amending Subsection (b) and adding Subsection (f) to read as follows:

- (b) Except as provided by Subsection (e), the commission by rule shall provide for licensing for the disposal of radioactive substances [material except for the disposal of by-product material defined by Section 401.003(3)(B). The department by rule shall provide for licensing the disposal of by-product material defined by Section 401.003(3)(B)].
- 23 <u>(f) A separate commercial storage and processing license</u>
 24 <u>may be issued for a site also licensed for disposal under this</u>
 25 <u>chapter.</u>
- SECTION 5. Subsection (a), Section 401.106, Health and Safety Code, is amended to read as follows:

- 1 (a) The board <u>or commission</u> by rule may exempt a source of
 2 radiation or a kind of use or user from the licensing or
 3 registration requirements provided by this chapter <u>and under the</u>
 4 <u>agency's jurisdiction</u> if the board <u>or commission</u> finds that the
 5 exemption of that source of radiation or kind of use or user will
 6 not constitute a significant risk to the public health and safety
 7 and the environment.
- 8 SECTION 6. Subsection (c), Section 401.108, Health and 9 Safety Code, is amended to read as follows:
- 10 (c) The [department or] commission shall reevaluate every
 11 five years the qualifications and security provided by a license
 12 holder under Subchapter F or Subchapter G. The reevaluation may
 13 coincide with license renewal procedures if renewal and
 14 reevaluation occur in the same year.
- SECTION 7. Subsection (b), Section 401.109, Health and Safety Code, is amended to read as follows:
- 17 (b) The [department or] commission shall require a holder of
 18 a license that authorizes the disposal of <u>radioactive substances</u>
 19 [low-level radioactive waste as provided by Subchapter F] to
 20 provide security acceptable to the <u>commission</u> [agency] to assure
 21 performance of the license holder's obligations under this chapter.
- SECTION 8. Section 401.111, Health and Safety Code, is amended to read as follows:
- Sec. 401.111. CRITERIA FOR CERTAIN UNSUITABLE NEW SITES.

 (a) The [board and] commission [each], in adopting rules for the issuance of licenses under the commission's jurisdiction [their respective jurisdictions] for new sites for processing or disposal

- of <u>radioactive substances</u> [low-level radioactive waste] from other
- 2 persons, shall adopt criteria for the designation of unsuitable
- 3 sites, including:
- 4 (1) flood hazard areas;
- 5 (2) areas with characteristics of discharge from or
- 6 recharge of a groundwater aquifer system; or
- 7 (3) areas in which soil conditions make spill cleanup
- 8 impracticable.
- 9 (b) The [board and] commission [each] shall consult with the
- 10 advisory board and with the Texas Water Development Board, the
- 11 State Soil and Water Conservation Board, the Bureau of Economic
- 12 Geology, and other appropriate state agencies in developing
- 13 proposed rules. The [board and] commission [each] by rule shall:
- 14 (1) require selection of sites in areas in which
- 15 natural conditions minimize potential contamination of surface
- 16 water and groundwater; and
- 17 (2) prohibit issuance of licenses for unsuitable sites
- 18 as defined by the rules.
- 19 SECTION 9. Section 401.112, Health and Safety Code, is
- 20 amended to read as follows:
- Sec. 401.112. LOW-LEVEL RADIOACTIVE WASTE PROCESSING OR
- 22 DISPOSAL LICENSE APPLICATION AND CONSIDERATIONS. (a) The
- 23 [department or] commission[, within its jurisdiction], in making a
- 24 licensing decision on a specific license application to process or
- 25 dispose of low-level radioactive waste from other persons, shall
- 26 consider:
- 27 (1) site suitability, geological, hydrological, and

- 1 meteorological factors, and natural [naturals] hazards;
- 2 (2) compatibility with present uses of land near the
- 3 site;
- 4 (3) socioeconomic effects on surrounding communities
- 5 of operation of the licensed activity and of associated
- 6 transportation of low-level radioactive waste;
- 7 (4) the need for and alternatives to the proposed
- 8 activity, including an alternative siting analysis prepared by the
- 9 applicant;
- 10 (5) the applicant's qualifications, including
- 11 financial and technical qualifications and compliance history
- 12 under the method for evaluation of compliance history developed by
- the commission under Section 5.754, Water Code, for an application
- 14 to the commission [or the requirements of Section 401.110(b) for an
- 15 application to the department];
- 16 (6) background monitoring plans for the proposed site;
- 17 (7) suitability of facilities associated with the
- 18 proposed activities;
- 19 (8) chemical, radiological, and biological
- 20 characteristics of the low-level radioactive waste and waste
- 21 classification under Section 401.053;
- 22 (9) adequate insurance of the applicant to cover
- 23 potential injury to any property or person, including potential
- 24 injury from risks relating to transportation;
- 25 (10) training programs for the applicant's employees;
- 26 (11) a monitoring, record-keeping, and reporting
- 27 program;

- 1 (12) spill detection and cleanup plans for the
- 2 licensed site and related to associated transportation of low-level
- 3 radioactive waste;
- 4 (13) decommissioning and postclosure care plans;
- 5 (14) security plans;
- 6 (15) worker monitoring and protection plans;
- 7 (16) emergency plans; and
- 8 (17) a monitoring program for applicants that includes
- 9 prelicense and postlicense monitoring of background radioactive
- 10 and chemical characteristics of the soils, groundwater, and
- 11 vegetation.
- 12 (b) An applicant for the specific license must submit with
- 13 the application information necessary for the commission [issuing
- 14 agency] to consider the factors under Subsection (a).
- 15 (c) The [board and] commission [each within its
- 16 jurisdiction] by rule shall provide specific criteria for the
- 17 different types of licensed low-level radioactive waste activities
- 18 for the listed factors and may include additional factors and
- 19 criteria that the [board or] commission[, as appropriate,]
- 20 determines necessary for full consideration of a license.
- SECTION 10. Subsections (a) and (b), Section 401.113,
- 22 Health and Safety Code, are amended to read as follows:
- 23 (a) Before a hearing under Section 401.114 begins, the
- 24 commission [agency holding the hearing] shall prepare or have
- 25 prepared a written analysis of the effect on the environment of a
- 26 proposed licensed activity that the commission [agency] determines
- 27 has a significant effect on the human environment.

- 1 (b) The <u>commission</u> [agency] shall make the analysis 2 available to the public not later than the 31st day before the date 3 of a hearing under Section 401.114.
- 4 SECTION 11. Section 401.114, Health and Safety Code, is 5 amended to read as follows:
- 6 Sec. 401.114. NOTICE AND HEARING. (a) Before the [department or] commission[, within its jurisdiction,] grants or 7 8 renews a license to process or dispose of low-level radioactive waste from other persons, the commission [agency] shall give notice 9 and shall provide an opportunity for a public hearing in the manner 10 provided by the commission's [agency's] formal hearing procedure 11 and Chapter 2001, Government Code. 12
 - (b) In addition to other notice, the <u>commission</u> [agency] shall publish notice of the hearing in the manner provided by Chapter 313, Government Code, in the county in which the proposed facility is to be located. The notice shall state the subject and the time, place, and date of the hearing.

- (c) The <u>commission</u> [agency] shall mail, by certified mail in the manner provided by the <u>commission's</u> [agency's] rules, written notice to each person who owns property adjacent to the proposed site. The notice must be mailed not later than the 31st day before the date of the hearing and must include the same information that is in the published notice. If true, the <u>commission</u> [agency] or the applicant must certify that the notice was mailed as required by this subsection, and at the hearing the certificate is conclusive evidence of the mailing.
- SECTION 12. Section 401.116, Health and Safety Code, is

1 amended to read as follows:

Sec. 401.116. LICENSE AMENDMENT. The commission shall adopt rules to establish requirements for public notice of and public participation in the amendment of a license issued under this subchapter, including both minor and major amendments, consistent with Section 401.054(c) [(a) An amendment to a license to process or dispose of low-level radioactive waste from other persons may take effect immediately.

- [(b) The department or commission, as appropriate, shall publish notice of the license amendment once in the Texas Register and in a newspaper of general circulation in the county in which the licensed activity is located and shall give notice to any person who has notified the agency, in advance, of the desire to receive notice of proposed amendment of the license.
- 15 [(c) Notice under this section must include:
- 16 [(1) the identity of the license holder;
- 17 [(2) identification of the license; and
- [(3) a short and plain statement of the license
 amendment's substance.
 - [(d) The agency shall give notice and hold a hearing to consider the license amendment if a person affected files a written complaint with the agency before the 31st day after the date on which notice is published under Subsection (b). The agency shall give notice of the hearing as provided by Section 401.114].
- 25 SECTION 13. Section 401.117, Health and Safety Code, is 26 amended to read as follows:
- Sec. 401.117. CONSTRUCTION LIMITATION. The [department or]

- 1 commission shall prohibit major construction relating to
- 2 activities to be permitted under a license issued by the commission
- 3 [agency] to process or dispose of low-level radioactive waste from
- 4 other persons until the requirements in Sections 401.113 and
- 5 401.114 are completed.
- 6 SECTION 14. Subsection (a), Section 401.202, Health and
- 7 Safety Code, is amended to read as follows:
- 8 (a) The commission [or department, within its respective
- 9 jurisdiction,] may grant, deny, renew, revoke, suspend, or withdraw
- 10 licenses for the disposal of low-level radioactive waste from other
- 11 persons and for the processing of that waste.
- 12 SECTION 15. Subsections (a) and (b), Section 401.241,
- 13 Health and Safety Code, are amended to read as follows:
- 14 (a) In determining the amount of security required of a
- 15 [compact waste disposal facility license] holder of a license to
- 16 <u>dispose of radioactive substances</u> under Section 401.109, the
- 17 commission shall also consider the need for financial security to
- 18 address and prevent unplanned events that pose a risk to public
- 19 health and safety and that may occur after the decommissioning and
- 20 closure of the <u>radioactive substances</u> [compact waste] disposal
- 21 facility [or a federal facility waste disposal facility licensed
- 22 <u>under Section 401.216</u>].
- 23 (b) The amount of security required of a compact waste
- 24 disposal facility license holder under this section may not be less
- 25 than \$20 million at the time the disposal facility site is
- 26 decommissioned. The commission shall use interest earned on the
- 27 security to offset any other financial obligations incurred by the

- 1 license holder to the commission. The commission shall establish a
- 2 schedule for the total payment of the amount of the security
- 3 required under this section based on:
- 4 (1) the amount of low-level radioactive waste received
- 5 at the site;
- 6 (2) the long-term risk to health, safety, and the
- 7 environment posed by the waste; and
- 8 (3) the need to address and prevent unplanned events
- 9 that pose a risk to public health and safety.
- 10 SECTION 16. Section 401.262, Health and Safety Code, is
- 11 amended to read as follows:
- 12 Sec. 401.262. MANAGEMENT OF CERTAIN BY-PRODUCT MATERIAL.
- 13 The commission [department] has sole and exclusive authority to
- 14 assure that processing and disposal sites are closed and that
- by-product material is managed and disposed of in compliance with:
- 16 (1) the federal commission's applicable standards; and
- 17 (2) closure criteria the federal commission and the
- 18 United States Environmental Protection Agency have determined are
- 19 protective of human health and safety and the environment.
- SECTION 17. Section 401.2625, Health and Safety Code, is
- 21 amended to read as follows:
- Sec. 401.2625. LICENSING AUTHORITY. The commission
- 23 [commissioner] has sole and exclusive authority to grant, deny,
- 24 renew, revoke, suspend, amend, or withdraw licenses for source
- 25 material recovery and processing or for storage, processing, or
- 26 disposal of by-product material.
- 27 SECTION 18. Subsections (a), (c), (d), (e), and (f),

- 1 Section 401.263, Health and Safety Code, are amended to read as
- 2 follows:
- 3 (a) If the commission [department] is considering the
- 4 issuance, renewal, or amendment of a license to process materials
- 5 that produce by-product materials or a license to dispose of
- 6 by-product material and the commission [department] determines
- 7 that the licensed activity will have a significant impact on the
- 8 human environment, the commission [department] shall prepare or
- 9 have prepared a written environmental analysis.
- 10 (c) The $\underline{\text{commission}}$ [$\underline{\text{department}}$] shall give notice of the
- analysis as provided by commission [board] rule and shall make the
- 12 analysis available to the public for written comment not later than
- 13 the 31st day before the date of the hearing on the license.
- (d) After notice is given, the commission [department]
- 15 shall provide an opportunity for written comments by persons
- 16 affected.
- 17 (e) The analysis shall be included as part of the record of
- 18 the commission's [department's] proceedings.
- 19 (f) The commission [board] by rule shall prohibit major
- 20 construction with respect to an activity that is to be licensed
- 21 until the requirements of Subsections (a), (b), (c), and (e) are
- 22 completed.
- 23 SECTION 19. Subsections (a), (c), and (d), Section 401.264,
- 24 Health and Safety Code, are amended to read as follows:
- 25 (a) The commission [department] on its own motion may or on
- 26 the written request of a person affected shall provide an
- 27 opportunity for a public hearing on an application over which the

- 1 <u>commission</u> [department] has jurisdiction to determine whether to
- 2 issue, renew, or amend a license to process materials that produce
- 3 by-product materials <u>or a license to dispose of by-product</u>
- 4 <u>materials</u> in the manner provided by Chapter 2001, Government Code,
- 5 and permit appearances with or without counsel and the examination
- 6 and cross-examination of witnesses under oath.
- 7 (c) The <u>commission</u> [department] shall make a record of the
- 8 proceedings and provide a transcript of the hearing on request of,
- 9 and payment for, the transcript or provision of a sufficient
- 10 deposit to assure payment by any person requesting the transcript.
- 11 (d) The commission [department] shall provide an
- 12 opportunity to obtain a written determination of action to be
- 13 taken. The determination must be based on evidence presented to the
- 14 commission [department] and include findings. The written
- 15 determination is available to the public.
- SECTION 20. Section 401.265, Health and Safety Code, is
- 17 amended to read as follows:
- 18 Sec. 401.265. CONDITIONS OF CERTAIN BY-PRODUCT MATERIAL
- 19 LICENSES. The commission [department] shall prescribe conditions
- in a radioactive substances [material] license issued, renewed, or
- 21 amended for an activity that results in production of by-product
- 22 material to minimize or, if possible, eliminate the need for
- 23 long-term maintenance and monitoring before the termination of the
- 24 license, including conditions that:
- 25 (1) the license holder will comply with the applicable
- 26 decontamination, decommissioning, reclamation, and disposal
- 27 standards that are prescribed by the commission [board] and that

- 1 are compatible with the federal commission's standards for sites at
- 2 which those ores were processed and at which the by-product
- 3 material is deposited; and
- 4 (2) the ownership of a disposal site, other than a
- 5 disposal well covered by a permit issued under Chapter 27, Water
- 6 Code, licensed on-site waste disposal associated with a licensed in
- 7 <u>situ leach uranium recovery facility</u>, and the by-product material
- 8 resulting from the licensed activity are transferred, subject to
- 9 Sections 401.266-401.269, to:
- 10 (A) the state; or
- 11 (B) the federal government if the state declines
- 12 to acquire the site, the by-product material, or both the site and
- 13 the by-product material.
- 14 SECTION 21. Subsection (a), Section 401.266, Health and
- 15 Safety Code, is amended to read as follows:
- 16 (a) The commission [board] by rule or [order or the
- 17 department by order may require that before a license covering
- 18 land used for the disposal of by-product material is terminated,
- 19 the land, including any affected interests in the land, must be
- 20 transferred to the federal government or to the state unless:
- 21 (1) the federal commission determines before the
- 22 license terminates that the transfer of title to the land and the
- 23 by-product material is unnecessary to protect the public health,
- 24 safety, or welfare or to minimize danger to life or property; or
- 25 (2) the land is held in trust by the federal government
- 26 for an Indian tribe, is owned by an Indian tribe subject to a
- 27 restriction against alienation imposed by the federal government,

- is owned by the federal government, or is owned by the state.
- 2 SECTION 22. Section 401.267, Health and Safety Code, is
- 3 amended to read as follows:
- 4 Sec. 401.267. ACQUISITION AND SALE OF CERTAIN BY-PRODUCT
- 5 MATERIALS AND SITES. (a) The commission [department] may acquire
- 6 by-product material and fee simple title in land, affected mineral
- 7 rights, and buildings at which that by-product material is disposed
- 8 of and abandoned so that the by-product material and property can be
- 9 managed in a manner consistent with protecting public health,
- 10 safety, and the environment.
- 11 (b) The commission [department] may sell land acquired
- 12 under this section at the land's fair market value after the
- 13 commission [department] has taken corrective action to restore the
- land to a condition that does not compromise the public health or
- 15 safety or the environment. The General Land Office shall negotiate
- 16 and close a transaction under this subsection on behalf of the
- 17 commission [department] using procedures under Section 31.158(c),
- 18 Natural Resources Code. Proceeds from the transaction shall be
- 19 deposited in the Texas capital trust fund.
- SECTION 23. Section 401.269, Health and Safety Code, is
- 21 amended to read as follows:
- Sec. 401.269. MONITORING, MAINTENANCE, AND EMERGENCY
- 23 MEASURES. (a) The <u>commission</u> [department] may undertake
- 24 monitoring, maintenance, and emergency measures in connection with
- 25 by-product material and property for which it has assumed custody
- 26 under Section 401.267 that are necessary to protect the public
- 27 health and safety and the environment.

- 1 (b) The <u>commission</u> [department] shall maintain the 2 by-product material and property transferred to it in a manner that 3 will protect the public health and safety and the environment.
- SECTION 24. Subsections (a), (b), (e), and (f), Section 401.270, Health and Safety Code, are amended to read as follows:

- (a) If the <u>commission</u> [department] finds that by-product material or the operation by which that by-product material is derived threatens the public health and safety or the environment, the <u>commission</u> [department] by order may require any action, including a corrective measure, that is necessary to correct or remove the threat.
 - order to a person responsible for an activity, including a past activity, concerning the recovery or processing of source material or the disposal of by-product material if it appears that there is an actual or threatened release of source material or by-product material that presents an imminent and substantial danger to the public health and safety or the environment, regardless of whether the activity was lawful at the time. The emergency order may be issued without notice or hearing.
- 21 (e) The <u>commission</u> [<u>department</u>] shall use the security 22 provided by the license holder to pay the costs of actions that are 23 taken or that are to be taken under this section. The <u>commission</u> 24 [<u>department</u>] shall send to the comptroller a copy of its order 25 together with necessary written requests authorizing the 26 comptroller to:
 - (1) enforce security supplied by the licensee;

- 1 (2) convert an amount of security into cash, as
- 2 necessary; and
- 3 (3) disburse from the security in the perpetual care
- 4 account the amount necessary to pay the costs.
- 5 (f) If an order issued by the commission [department] under
- 6 this section is adopted without notice or hearing, the order shall
- 7 set a time, at least 10 but not more than 30 days following the date
- 8 of issuance of the emergency order, and a place for a hearing to be
- 9 held in accordance with the rules of the commission [board]. As a
- 10 result of this hearing, the commission [department] shall decide
- 11 whether to affirm, modify, or set aside the emergency order. All
- 12 provisions of the emergency order shall remain in force and effect
- during the pendency of the hearing, unless otherwise altered by the
- 14 commission [department].
- SECTION 25. Subchapter G, Chapter 401, Health and Safety
- 16 Code, is amended by adding Sections 401.271 and 401.272 to read as
- 17 follows:
- Sec. 401.271. STATE FEE ON RADIOACTIVE SUBSTANCES. (a) A
- 19 holder of a license issued by the commission under this chapter that
- 20 authorizes the disposal of a radioactive substance from other
- 21 persons shall remit each quarter an amount equal to 10 percent of
- 22 the license holder's gross receipts received from disposal
- 23 operations under a license issued under this chapter that occur
- 24 after the effective date of the Act enacting this section as
- 25 follows:

- 19 Environmental Quality shall give priority to the review and
- 20 processing of:
- 21 (1) an application for the commercial disposal of
- 22 by-product material;
- 23 (2) an application for termination of a license to
- 24 recover or process source material and dispose of associated
- 25 by-product material generated in this state; and
- 26 (3) a new application for a permit to recover or
- 27 process source material and dispose of associated by-product

- 1 material generated in this state.
- 2 SECTION 40. Notwithstanding other law or any rule on the
- 3 subject of timeliness of an applicant providing information
- 4 pertaining to an application for a license from the Texas
- 5 Commission on Environmental Quality, the applicant for a license
- 6 shall assist the commission in meeting any deadlines imposed by
- 7 Chapter 401, Health and Safety Code, by submitting to the
- 8 commission any information the commission requires regarding the
- 9 application in a prompt and timely manner.
- SECTION 41. (a) On the earlier of the 31st day after the
- 11 effective date of this Act or November 1, 2005:
- 12 (1) all money appropriated to the Department of State
- 13 Health Services for the regulation of the commercial storage and
- 14 processing and the disposal of radioactive waste, except money
- 15 related to the regulation of oil and gas naturally occurring
- 16 radioactive material waste, is transferred to the Texas Commission
- on Environmental Quality, including \$447,608 out of the General
- 18 Revenue Fund in each fiscal year of the state fiscal biennium
- 19 beginning September 1, 2005; and
- 20 (2) eight full-time equivalent employees of the
- 21 Department of State Health Services working in the regulation of
- 22 the commercial storage and processing and the disposal of
- 23 radioactive waste, except those employees whose work is related to
- 24 the regulation of oil and gas naturally occurring radioactive
- 25 material waste, are transferred to the Texas Commission on
- 26 Environmental Quality.
- (b) Fee revenues deposited to the credit of the General

- 1 Revenue Fund (No. 0001), Revenue Code 3589, are appropriated to the
- 2 Texas Commission on Environmental Quality in the amounts not to
- 3 exceed \$1,181,156 for the state fiscal year beginning September 1,
- 4 2005, and not to exceed \$1,064,656 for the state fiscal year
- 5 beginning September 1, 2006.
- 6 (c) The Texas Commission on Environmental Quality shall use
- 7 the appropriated money to regulate radioactive waste as provided by
- 8 Chapter 401, Health and Safety Code.
- 9 (d) The number of full-time equivalent employees authorized
- 10 for the Texas Commission on Environmental Quality is increased by
- 11 eight for each fiscal year of the state fiscal biennium beginning
- 12 September 1, 2005.
- (e) The governor with the advice of the Legislative Budget
- 14 Board may resolve any disputes concerning the transfer of
- 15 appropriations and employees from the Department of State Health
- 16 Services to the Texas Commission on Environmental Quality under
- 17 this Act.
- 18 SECTION 42. This Act takes effect immediately if it
- 19 receives a vote of two-thirds of all the members elected to each
- 20 house, as provided by Section 39, Article III, Texas Constitution.
- 21 If this Act does not receive the vote necessary for immediate
- effect, this Act takes effect November 1, 2005.
