(b) The board of regents may pledge irrevocably to the payment of the bonds authorized by this section all or any part of the revenue funds of an institution, branch, or entity of The University of Texas System, including student tuition charges. The amount of a pledge made under this subsection may not be reduced or abrogated while the bonds for which the pledge is made, or bonds issued to refund those bonds, are outstanding.

17 (e) Approval of the board is not required to acquire real property that is financed by bonds issued under Section 55.17(e)(3) 18 or (4), 55.1713-55.1718, 55.1721-55.1728, 55.1735(a)(1), 55.174, 19 55.1742, 55.1743, [or] 55.1744, or 55.1752, except that the board 20 21 shall review all real property to be financed by bonds issued under those sections to determine whether the property meets the 22 standards adopted by the board for cost, efficiency, and space use. 23 24 If the property does not meet those standards, the board shall notify the governor, the lieutenant governor, the speaker of the 25 26 house of representatives, and the Legislative Budget Board.

27 SECTION 3. Section 61.058(b), Education Code, is amended to

This section does not apply to construction, repair, or 2 (b) rehabilitation financed by bonds issued under Section 55.17(e)(3) 3 4 (4), 55.1713-55.1718, 55.1721-55.1728, 55.174, 55.1742, or 55.1743, [or] 55.1744, or 55.1752, except that the board shall 5 review all construction, repair, or rehabilitation to be financed 6 by bonds issued under those sections to determine whether the 7 construction, rehabilitation, or repair meets the standards 8 adopted by board rule for cost, efficiency, and space use. If the 9 construction, rehabilitation, or repair does not meet those 10 standards, the board shall notify the governor, the lieutenant 11 governor, the speaker of the house of representatives, and the 12 Legislative Budget Board. 13

SECTION 4. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this Act takes effect on the 91st day after the last day of the legislative session.
