## A BILL TO BE ENTITLED 1 AN ACT 2 relating to the compensation of state judges and county judges, to 3 retirement benefits for state judges, and to providing funds for court-related purposes; making an appropriation. 4 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 6 SECTION 1. Section 659.012, Government Code, is amended to read as follows: 7 Sec. 659.012. JUDICIAL SALARIES. (a) 8 Notwithstanding Section 659.011: 9 (1) a judge of a district court is entitled to an 10 11 annual salary from the state of at least \$125,000, except that the 12 combined salary of a district judge from state and county sources, including compensation for any extrajudicial services performed on 13 14 behalf of the county, may not exceed the amount that is \$5,000 less than the salary provided for a justice of a court of appeals other 15 16 than a chief justice [justice of the supreme court is entitled to an annual salary from the state that is at least \$102,463]; 17 18 (2) a justice of a court of appeals other than the chief justice is entitled to an annual salary from the state that is 19 equal to 110 percent of the salary of a district judge [five percent 20 21 less than the salary provided by the General Appropriations Act for a justice of the supreme court], except that the combined salary of 22 a justice of the court of appeals other than the chief justice from 23 all state and county sources, including compensation for any 24

1 <u>extrajudicial services performed on behalf of the county</u>, may not 2 exceed the amount that is <u>\$5,000</u> [<del>\$1,000</del>] less than the salary 3 provided for a justice of the supreme court;

4 (3) <u>a justice of the supreme court other than the chief</u>
5 justice or a judge of the court of criminal appeals other than the
6 presiding judge is entitled to an annual salary from the state that
7 is equal to 120 percent of the salary of a district judge; and

8 (4) the chief justice <u>or presiding judge</u> of <u>an</u> 9 <u>appellate</u> [<del>a</del>] court [<del>of appeals</del>] is entitled to an annual salary 10 from the state that is \$2,500 more than the salary provided for the 11 other justices <u>or judges</u> of the court [<del>of appeals</del>], except that the 12 combined salary of the chief justice of a court of appeals may not 13 exceed the amount that is <u>\$2,500</u> [<del>\$500</del>] less than the salary 14 provided for a justice of the supreme court[<del>, and</del>

15 [(4) a judge of a district court is entitled to an annual salary from the state that is 10 percent less than the salary provided in the General Appropriations Act for a justice of the supreme court, except that unless otherwise provided by law, the combined salary of a district judge from state and county sources may not exceed the amount that is \$2,000 less than the salary provided for a justice of the supreme court].

(b) To the extent of any conflict, the salary <u>limitations</u>
[differential] provided by this section for the combined salary of
a <u>state</u> [district] judge <u>or justice from state and local sources</u>
prevails over any <u>provision of Chapter 31 or</u> [differential set by
<u>Chapter</u>] 32 <u>that authorizes the payment of additional compensation</u>
to a state judge or justice.

1 (d) In a county with more than five district courts, a 2 district judge who serves as a local administrative district judge 3 under Section 74.091 is entitled to an annual salary from the state 4 that is \$5,000 more than the salary from the state to which the 5 judge is otherwise entitled under Subsection (a)(1) [(c)].

6 (e) For the purpose of salary payments by the state, the comptroller shall determine from sworn statements filed by the 7 8 justices of the courts of appeals and district judges that the 9 required salary limitations [differentials] provided by this 10 section are maintained. If a salary combined with additional compensation from a county [supplement] would be in excess of the 11 [differential] provided by this section, 12 limitations the comptroller shall reduce the state salary by the amount of the 13 14 excess.

15 SECTION 2. Section 26.006(a), Government Code, is amended 16 to read as follows:

(a) A county judge is entitled to an annual salary
supplement from the state of \$15,000 [\$10,000] if at least 40
percent of the functions that the judge performs are judicial
functions.

21 SECTION 3. Section 31.001, Government Code, is amended to 22 read as follows:

23 Sec. 31.001. AUTHORITY FOR COUNTY PAYMENT OF COMPENSATION. 24 The commissioners courts in the counties of each of the 14 courts of 25 appeals districts may pay <u>additional compensation in</u> an amount <u>that</u> 26 <u>does</u> not [<del>to</del>] exceed <u>the limitations of Section 659.012</u> [<del>\$15,000 a</del> 27 <del>year</del>] to each of the justices of the courts of appeals residing

ADDITIONAL COMPENSATION [SUPPLEMENTAL SALARY] PAID 10 BY COUNTY FOR EXTRAJUDICIAL SERVICES 11 SECTION 6. Section 32.001, Government Code, is amended to 12 read as follows: 13 Sec. 32.001. AUTHORITY FOR ADDITIONAL COMPENSATION 14 15 [ANDERSON COUNTY]. (a) The commissioners court of a county [Commissioners Court of Anderson County] may pay the judges of the 16 17 district courts having jurisdiction in the county additional compensation in an amount that does not exceed the limitations of 18 Section 659.012 for extrajudicial [an annual salary not to exceed 19 \$1,200 for judicial and administrative] services performed by the 20 21 district judges. 11	judge. Notwithstanding any other law, the combined salary from all

13	board may not exceed an amount that is \$5,000 less than the salary
14	provided by the state for a justice of a court of appeals other than
15	the chief justice.
16	SECTION 8. Subchapter C, Chapter 72, Government Code, is
17	amended by adding Section 72.030 to read as follows:
18	Sec. 72.030. COLLECTION OF DATA RELATING TO JUDICIAL
19	TURNOVER. (a) The office biennially shall collect data relating
20	to:
21	(1) the rate at which state judges resign from office

24	(b) Not later than December 1 of each even-numbered year,
25	the office shall file a report containing the data collected under
26	Subsection (a) for the preceding state fiscal biennium with the
27	governor, the lieutenant governor, the speaker of the house of

1	representatives, and the presiding officers of the standing
2	committees of each house of the legislature with jurisdiction over
3	the judiciary or appropriations.
4	(c) The report filed under Subsection (b) must include the
5	following findings:
6	(1) whether the compensation of state judges exceeds,
7	is equal to, or is less than the compensation of judges at
8	corresponding levels in the five states closest in population to
9	this state; and
10	(2) whether the compensation of state judges exceeds,
11	is equal to, or is less than the average salary of lawyers engaged
12	in the private practice of law.
13	(d) The purpose of filing the report with the legislature is
14	to provide the legislature with information to facilitate
15	legislation that ensures that the compensation of state judges is
16	adequate and appropriate.
17	SECTION 9. Section 840.1027(b), Government Code, as added
18	by House Bill No. 617, Acts of the 79th Legislature, Regular
19	Session, 2005, is amended to read as follows:
20	(b) A member who elects to make contributions under
21	Subsection (a) shall contribute six percent of the member's state
22	compensation for each payroll period in the manner provided by
23	Sections 840.102(b)-(f). [Section 840.105 does not apply to a
24	contribution under this section.]
25	SECTION 10. Section 133.003, Local Government Code, is
26	amended to conform to Senate Bill No. 1704, Acts of the 79th

14	(c) The treasurer shall remit the remainder of the fees
15	collected under this section to the comptroller in the manner
16	provided by Subchapter B. The comptroller shall deposit the fees in
17	the judicial fund.
18	SECTION 13. Subchapter D, Chapter 133, Local Government

8 SECTION 21. Not later than February 1, 2006, the Office of 9 Court Administration of the Texas Judicial System shall begin 10 collecting the data required by Section 72.030, Government Code, as 11 added by this Act.

SECTION 22. For purposes of determining the salary of a county official that is based on the salary paid to a district judge by the state, the changes in law made by this Act take effect December 1, 2005, and apply only to a salary payment made on or after that date. A salary payment made before December 1, 2005, is governed by the law in effect on the date the salary payment was made, and that law is continued in effect for that purpose.

SECTION 23. The imposition of a cost of court under Section 19 133.105, Local Government Code, as added by this Act, applies only 20 to an offense committed on or after the effective date of this Act. 21 An offense committed before the effective date of this Act is 22 23 covered by the law in effect when the offense was committed, and the 24 former law is continued in effect for that purpose. For purposes of 25 this section, an offense was committed before the effective date of this Act if any element of the offense was committed before that 26 27 date.

1 SECTION 24. On December 1, 2005, the Employees Retirement 2 System of Texas shall recompute under Section 839.102, Government Code, as amended by H.B. No. 1114, Acts of the 79th Legislature, 3 Regular Session, 2005, the annuities of persons who have retired, 4 or the annuities of beneficiaries of persons who have died, as if 5 6 the persons had retired or died under the lesser of the salary provisions of Subtitle E, Title 8, Government Code, or the salary 7 provisions of S.B. No. 1, Acts of the 79th Legislature, Regular 8 Session, 2005 (the General Appropriations Act). The first payment 9 of the recomputed annuities becomes payable on the first date a 10 payment becomes due after the effective date of this Act. 11

SECTION 25. This Act takes effect December 1, 2005.
