A BILL TO BE ENTITLED

1	AN ACT

- 2 relating to the compensation of state judges and county judges, to
- 3 retirement benefits for state judges, and to providing funds for
- 4 court-related purposes; making an appropriation.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. Section 659.012, Government Code, is amended to
- 7 read as follows:
- 8 Sec. 659.012. JUDICIAL SALARIES. (a) Notwithstanding
- 9 Section 659.011:
- 10 (1) a judge of a district court is entitled to an
- annual salary from the state of at least \$125,000, except that the
- 12 combined salary of a district judge from state and county sources,
- 13 <u>including compensation for any extrajudicial services performed on</u>
- behalf of the county, may not exceed the amount that is \$5,000 less
- 15 than the salary provided for a justice of a court of appeals other
- 16 than a chief justice [justice of the supreme court is entitled to an
- 17 annual salary from the state that is at least \$102,463];
- 18 (2) a justice of a court of appeals other than the
- 19 chief justice is entitled to an annual salary from the state that is
- 20 equal to 110 percent of the salary of a district judge [five percent
- 21 less than the salary provided by the General Appropriations Act for
- 22 a justice of the supreme court], except that the combined salary of
- 23 a justice of the court of appeals other than the chief justice from
- 24 all state and county sources, including compensation for any

- 1 <u>extrajudicial services performed on behalf of the county,</u> may not
- 2 exceed the amount that is \$5,000 [\$1,000] less than the salary
- 3 provided for a justice of the supreme court;
- 4 (3) <u>a justice of the supreme court other than the chief</u>
- 5 justice or a judge of the court of criminal appeals other than the
- 6 presiding judge is entitled to an annual salary from the state that
- 7 <u>is equal to 120 percent of the salary of a district judge; and</u>
- 8 <u>(4)</u> the chief justice <u>or presiding judge</u> of <u>an</u>
- 9 $\underline{appellate}$ [\underline{a}] court [\underline{of} $\underline{appeals}$] is entitled to an annual salary
- 10 from the state that is \$2,500 more than the salary provided for the
- other justices or judges of the court [of appeals], except that the
- 12 combined salary of the chief justice of a court of appeals may not
- 13 exceed the amount that is \$2,500 [\$500] less than the salary
- 14 provided for a justice of the supreme court[; and
- 15 [(4) a judge of a district court is entitled to an
- 16 annual salary from the state that is 10 percent less than the salary
- 17 provided in the General Appropriations Act for a justice of the
- 18 supreme court, except that unless otherwise provided by law, the
- 19 combined salary of a district judge from state and county sources
- 20 may not exceed the amount that is \$2,000 less than the salary
- 21 provided for a justice of the supreme court].
- 22 (b) To the extent of any conflict, the salary <u>limitations</u>
- 23 [differential] provided by this section for the combined salary of
- 24 a <u>state</u> [<u>district</u>] judge <u>or justice from state and local sources</u>
- 25 prevails over any provision of Chapter 31 or [differential set by
- 26 Chapter] 32 that authorizes the payment of additional compensation
- 27 to a state judge or justice.

- 1 (d) In a county with more than five district courts, a 2 district judge who serves as a local administrative district judge 3 under Section 74.091 is entitled to an annual salary from the state 4 that is \$5,000 more than the salary from the state to which the 5 judge is otherwise entitled under Subsection (a)(1) [(e)].
- 6 (e) For the purpose of salary payments by the state, the comptroller shall determine from sworn statements filed by the 7 8 justices of the courts of appeals and district judges that the 9 required salary limitations [differentials] provided by this 10 section are maintained. If a salary combined with additional compensation from a county [supplement] would be in excess of the 11 [differential] provided by this section, 12 limitations comptroller shall reduce the state salary by the amount of the 13 14 excess.
- SECTION 2. Section 26.006(a), Government Code, is amended to read as follows:
- 17 (a) A county judge is entitled to an annual salary
 18 supplement from the state of \$15,000 [\$10,000] if at least 40
 19 percent of the functions that the judge performs are judicial
 20 functions.
- 21 SECTION 3. Section 31.001, Government Code, is amended to 22 read as follows:
- Sec. 31.001. AUTHORITY FOR COUNTY PAYMENT OF COMPENSATION.

 The commissioners courts in the counties of each of the 14 courts of appeals districts may pay additional compensation in an amount that does not [to] exceed the limitations of Section 659.012 [\$15,000 a year] to each of the justices of the courts of appeals residing

- 1 within the court of appeals district that includes those counties.
- 2 The compensation [payment] is for all extrajudicial [judicial and
- 3 administrative] services performed by the justices.
- 4 SECTION 4. The heading to Chapter 32, Government Code, is
- 5 amended to read as follows:
- 6 CHAPTER 32. ADDITIONAL [SUPPLEMENTAL] COMPENSATION OF DISTRICT
- 7 JUDGES [FOR CERTAIN DUTIES]
- 8 SECTION 5. The heading to Subchapter A, Chapter 32,
- 9 Government Code, is amended to read as follows:
- 10 SUBCHAPTER A. <u>ADDITIONAL COMPENSATION</u> [SUPPLEMENTAL SALARY] PAID
- BY COUNTY FOR EXTRAJUDICIAL SERVICES
- 12 SECTION 6. Section 32.001, Government Code, is amended to
- 13 read as follows:
- 14 Sec. 32.001. AUTHORITY FOR ADDITIONAL COMPENSATION
- 15 [ANDERSON COUNTY]. (a) The commissioners court of a county
- 16 [Commissioners Court of Anderson County] may pay the judges of the
- 17 district courts having jurisdiction in the county additional
- 18 compensation in an amount that does not exceed the limitations of
- 19 <u>Section 659.012 for extrajudicial</u> [an annual salary not to exceed
- 20 \$1,200 for judicial and administrative] services performed by the
- 21 district judges.
- 22 (b) The compensation [salary] shall be paid in monthly
- 23 installments from the county general fund or other available funds
- of the county.
- 25 (c) The compensation [salary] is in addition to the salary
- 26 paid by the state and any other compensation authorized by law.
- 27 [(d) The aggregate amount of \$2,900 is the maximum

- 1 supplemental salary that may be paid under this subchapter to a
- 2 judge of a district court having jurisdiction in Anderson County
- 3 from all counties that comprise a part of a judicial district
- 4 consisting of not less than four counties, of which two of those
- 5 counties have two or more district courts.
- 6 SECTION 7. Section 152.0003, Human Resources Code, is 7 amended to read as follows:
- 8 Sec. 152.0003. COMPENSATION. The compensation authorized
- 9 under this chapter for a judge serving on a juvenile board is in
- 10 addition to all other compensation provided or allowed by law for a
- judge. Notwithstanding any other law, the combined salary from all
- 12 state and local sources of a district judge serving on a juvenile
- board may not exceed an amount that is \$5,000 less than the salary
- 14 provided by the state for a justice of a court of appeals other than
- 15 the chief justice.
- SECTION 8. Subchapter C, Chapter 72, Government Code, is
- amended by adding Section 72.030 to read as follows:
- 18 Sec. 72.030. COLLECTION OF DATA RELATING TO JUDICIAL
- 19 TURNOVER. (a) The office biennially shall collect data relating
- 20 to:
- 21 (1) the rate at which state judges resign from office
- 22 or do not seek reelection; and
- 23 (2) the reason for action under Subdivision (1).
- (b) Not later than December 1 of each even-numbered year,
- 25 the office shall file a report containing the data collected under
- 26 Subsection (a) for the preceding state fiscal biennium with the
- 27 governor, the lieutenant governor, the speaker of the house of

- 1 representatives, and the presiding officers of the standing
- 2 committees of each house of the legislature with jurisdiction over
- 3 the judiciary or appropriations.
- 4 (c) The report filed under Subsection (b) must include the
- 5 following findings:
- 6 (1) whether the compensation of state judges exceeds,
- 7 is equal to, or is less than the compensation of judges at
- 8 corresponding levels in the five states closest in population to
- 9 this state; and
- 10 (2) whether the compensation of state judges exceeds,
- is equal to, or is less than the average salary of lawyers engaged
- 12 in the private practice of law.
- 13 (d) The purpose of filing the report with the legislature is
- 14 to provide the legislature with information to facilitate
- 15 legislation that ensures that the compensation of state judges is
- 16 <u>adequate and appropriate.</u>
- 17 SECTION 9. Section 840.1027(b), Government Code, as added
- 18 by House Bill No. 617, Acts of the 79th Legislature, Regular
- 19 Session, 2005, is amended to read as follows:
- 20 (b) A member who elects to make contributions under
- 21 Subsection (a) shall contribute six percent of the member's state
- 22 compensation for each payroll period in the manner provided by
- 23 Sections 840.102(b)-(f). [Section 840.105 does not apply to a
- 24 contribution under this section.
- 25 SECTION 10. Section 133.003, Local Government Code, is
- 26 amended to conform to Senate Bill No. 1704, Acts of the 79th

- 2 Sec. 133.105. FEE FOR SUPPORT OF COURT-RELATED PURPOSES.
- 3 (a) A person convicted of any offense, other than an offense
- 4 relating to a pedestrian or the parking of a motor vehicle, shall
- 5 pay as a court cost, in addition to all other costs, a fee of \$4 to
- 6 be used for court-related purposes for the support of the
- 7 judiciary.
- 8 (b) The treasurer shall deposit 60 cents of each fee
- 9 collected under this section in the general fund of the
- 10 municipality or county to promote the efficient operation of the
- 11 municipal or county courts and the investigation, prosecution, and
- 12 enforcement of offenses that are within the jurisdiction of the
- 13 courts.
- 14 (c) The treasurer shall remit the remainder of the fees
- 15 <u>collected under this section to the comptroller in the manner</u>
- 16 provided by Subchapter B. The comptroller shall deposit the fees in
- 17 the judicial fund.
- 18 SECTION 13. Subchapter D, Chapter 133, Local Government
- 19 Code, is amended by adding Section 133.154 to read as follows:
- Sec. 133.154. ADDITIONAL FILING FEE IN DISTRICT COURT,
- 21 STATUTORY COUNTY COURT, OR COUNTY COURT FOR SUPPORT OF JUDICIARY.
- 22 (a) In addition to other fees authorized or required by law, the
- 23 <u>clerk of a district court, statutory county court, or county court</u>
- shall collect a fee of \$37 on the filing of any civil suit to be used
- 25 for court-related purposes for the support of the judiciary.
- 26 (b) The treasurer shall remit the fees collected under this
- 27 section to the comptroller in the manner provided by Subchapter B.

- 2 (2) Section 4, Chapter 62, Acts of the 78th
- 3 Legislature, Regular Session, 2003;

- 8 SECTION 21. Not later than February 1, 2006, the Office of
- 9 Court Administration of the Texas Judicial System shall begin
- 10 collecting the data required by Section 72.030, Government Code, as
- 11 added by this Act.
- 12 SECTION 22. For purposes of determining the salary of a
- 13 county official that is based on the salary paid to a district judge
- 14 by the state, the changes in law made by this Act take effect
- 15 December 1, 2005, and apply only to a salary payment made on or
- 16 after that date. A salary payment made before December 1, 2005, is
- 17 governed by the law in effect on the date the salary payment was
- 18 made, and that law is continued in effect for that purpose.
- 19 SECTION 23. The imposition of a cost of court under Section
- 20 133.105, Local Government Code, as added by this Act, applies only
- 21 to an offense committed on or after the effective date of this Act.
- 22 An offense committed before the effective date of this Act is
- 23 covered by the law in effect when the offense was committed, and the
- 24 former law is continued in effect for that purpose. For purposes of
- 25 this section, an offense was committed before the effective date of
- 26 this Act if any element of the offense was committed before that
- 27 date.

1 SECTION 24. On December 1, 2005, the Employees Retirement 2 System of Texas shall recompute under Section 839.102, Government Code, as amended by H.B. No. 1114, Acts of the 79th Legislature, 3 Regular Session, 2005, the annuities of persons who have retired, 4 or the annuities of beneficiaries of persons who have died, as if 5 6 the persons had retired or died under the lesser of the salary provisions of Subtitle E, Title 8, Government Code, or the salary 7 provisions of S.B. No. 1, Acts of the 79th Legislature, Regular 8 Session, 2005 (the General Appropriations Act). The first payment 9 of the recomputed annuities becomes payable on the first date a 10 payment becomes due after the effective date of this Act. 11

12 SECTION 25. This Act takes effect December 1, 2005.
