A BILL TO BE ENTITLED

1 AN ACT

2 relating to authorizing the issuance of revenue bonds for Texas

- 3 Southern University.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Subchapter B, Chapter 55, Education Code, is
- 6 amended by adding Section 55.17591 to read as follows:
- 7 Sec. 55.17591. TEXAS SOUTHERN UNIVERSITY; ADDITIONAL
- 8 BONDS. (a) In addition to the other authority granted by this
- 9 subchapter, the board of regents of Texas Southern University may
- 10 acquire, purchase, construct, improve, renovate, enlarge, or equip
- 11 facilities, including roads and related infrastructure, for a
- 12 multipurpose university center, a fine arts building, a building
- 13 for the school of technology, the Robert J. Terry Library, and
- 14 deferred maintenance of campus facilities and infrastructure, to be
- 15 financed through the issuance of bonds in accordance with this
- 16 subchapter in an aggregate principal amount not to exceed
- 17 \$109,560,000.
- 18 (b) The board may pledge irrevocably to the payment of bonds
- 19 authorized by this section all or any part of the revenue funds of
- 20 Texas Southern University, including student tuition charges. The
- 21 amount of a pledge made under this subsection may not be reduced or
- 22 abrogated while the bonds for which the pledge is made, or bonds
- issued to refund those bonds, are outstanding.
- SECTION 2. Section 61.0572(e), Education Code, is amended

- 1 to read as follows:
- 2 (e) Approval of the board is not required to acquire real
- 3 property that is financed by bonds issued under Section 55.17(e)(3)
- 4 or (4), 55.1713-55.1718, 55.1721-55.1728, 55.1735(a)(1), 55.174,
- 5 55.1742, 55.1743, [or 55.1744, or 55.17591, except that the board
- 6 shall review all real property to be financed by bonds issued under
- 7 those sections to determine whether the property meets the
- 8 standards adopted by the board for cost, efficiency, and space use.
- 9 If the property does not meet those standards, the board shall
- 10 notify the governor, the lieutenant governor, the speaker of the
- 11 house of representatives, and the Legislative Budget Board.
- 12 SECTION 3. Section 61.058(b), Education Code, is amended to
- 13 read as follows:
- 14 (b) This section does not apply to construction, repair, or
- rehabilitation financed by bonds issued under Section 55.17(e)(3)
- 16 or (4), 55.1713-55.1718, 55.1721-55.1728, 55.174, 55.1742,
- 17 55.1743, [or] 55.1744, or 55.17591, except that the board shall
- 18 review all construction, repair, or rehabilitation to be financed
- 19 by bonds issued under those sections to determine whether the
- 20 construction, rehabilitation, or repair meets the standards
- 21 adopted by board rule for cost, efficiency, and space use. If the
- 22 construction, rehabilitation, or repair does not meet those
- 23 standards, the board shall notify the governor, the lieutenant
- 24 governor, the speaker of the house of representatives, and the
- 25 Legislative Budget Board.
- 26 SECTION 4. This Act takes effect immediately if it receives
- 27 a vote of two-thirds of all the members elected to each house, as

- 1 provided by Section 39, Article III, Texas Constitution. If this
- 2 Act does not receive the vote necessary for immediate effect, this
- 3 Act takes effect on the 91st day after the last day of the
- 4 legislative session.
