WHEREAS, The passing of Lucille McLaughlin of Alpine and Port 1 2 Lavaca on June 19, 2005, at the age of 88, has left behind a host of 3 loved ones who treasure the richness she brought to their lives; and WHEREAS, Born Lucille Edna Shay on July 7, 1916, in Syracuse, 4 5 New York, Mrs. McLaughlin grew up in a close-knit family with the companionship of a brother, Martin, and two sisters, Pauline and 6 Gloria; after graduating from high school, she attended a business 7 school in her hometown and then worked as a secretary, first for a 8 local merchant and later on a naval base in Bermuda; and 9 WHEREAS, In 1942, Mrs. McLaughlin took a cross-country train 10 11 trip from New York to Seattle, Washington, to exchange wedding vows 12 with Chief Petty Officer Frank Raymond "Ray" McLaughlin on October 13 26, while the groom was on a brief leave from his assignment in the 14 Aleutian Islands; the couple enjoyed a loving marriage for nearly six decades, until Mr. McLaughlin's passing in 2001; and 15 WHEREAS, Mrs. McLaughlin took great satisfaction in her roles 16 as a devoted wife and as the mother of two treasured children, and 17 18 life was further enriched with the arrival of four grandchildren and four great-grandchildren; and 19 WHEREAS, Mr. McLaughlin's military career took the family to 20 21 various posts within the United States and overseas; following retirement, the couple continued their journeys, visiting nearly 22 every continent in the course of either vacationing or attending 23

1 WHEREAS, After moving from Florida to Alpine in 1975, the 2 McLaughlins became active residents of that West Texas community; 3 they were among the founding congregants of Holy Cross Anglican 4 Church, where Mrs. McLaughlin shared her time and talents as a 5 member of the altar guild; and

WHEREAS, The pair were also leaders of Lions District 2-T3; Mrs. McLaughlin served as First Lady of the district while her husband held the office of district governor in 1981-1982, and she later served as First Lady of the Texas Lions Camp, a facility for ill and disabled children, during Mr. McLaughlin's tenure as camp president in 1989-1990; in addition, Mrs. McLaughlin held the distinction of being the first female member of the Alpine Noon Lions Club; and

WHEREAS, In 2001, Mrs. McLaughlin relocated to Port Lavaca to be closer to her children; throughout her life, this admired individual was an avid gardener and traveler who took pleasure in bird watching, enjoyed good food, and won the hearts of all who knew her; and

WHEREAS, Though she is sorely missed, the memory of Lucille McLaughlin's many kindnesses and warm and generous nature will long be cherished by those who were fortunate to share in her love and affection; now, therefore, be it
