| 8 | Sec. 55.1751. THE TEXAS A&M UNIVERSITY SYSTEM; ADDITIONAL |
| 9 | BONDS. (a) In addition to the other authority granted by this |
| 10 | subchapter, the board of regents of The Texas A&M University System |
| 11 | may acquire, purchase, construct, improve, renovate, enlarge, or |
| 12 | equip facilities, including roads and related infrastructure, for |
| 13 | projects to be financed through the issuance of bonds in accordance |
| 14 | with this subchapter and in accordance with a systemwide revenue |
| 15 | financing program adopted by the board for the following |
| 16 | institutions not to exceed the following aggregate principal |
| 17 | amounts for the projects specified as follows: |
| 18 | (1) Texas A&M UniversityKingsville System |
| 19 | CenterSan Antonio, \$80 million for education-related facilities |
| 20 | at the location proposed for Texas A&M UniversitySan Antonio; and |
| 21 | (2) Texas A&M UniversityTexarkana, \$65 million for |

or (4), 55.1713-55.1718, 55.1721-55.1728, 55.174, 55.1742, 1 2 55.1743, [or 55.1744, or 55.1751, except that the board shall review all construction, repair, or rehabilitation to be financed 3 4 by bonds issued under those sections to determine whether the construction, rehabilitation, or repair meets the standards 5 6 adopted by board rule for cost, efficiency, and space use. If the construction, rehabilitation, or repair does not meet those 7 8 standards, the board shall notify the governor, the lieutenant 9 governor, the speaker of the house of representatives, and the Legislative Budget Board. 10

SECTION 4. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this Act takes effect on the 91st day after the last day of the legislative session.
