2 director of guidance and counseling with the Keller Independent  
3 School District, and members of her community are joining together  
4 to pay tribute to this esteemed woman on May 6, 2006; and

5           WHEREAS, Mrs. Casey earned her bachelor's degree in secondary  
6 education and her master of education degree in counseling from the  
7 University of North Texas; she joined Keller ISD in 1973, and during  
8 the past three decades, she has lovingly guided a generation of  
9 children both as a teacher and a counselor; and

10           WHEREAS, She has further contributed to her chosen field by  
11 leading district-wide initiatives, including the Keller ISD Crisis  
12 Management Plan, the restructuring of the Guidance and Counseling  
13 Program for grades K-12, and the parent education program Love and  
14 Logic; and

16 acclaim; named Counselor Supervisor of the Year, she has also  
17 received the Hero Award for Outstanding Service to Children, the
