

R E S O L U T I O N

1 WHEREAS, The citizens of Dallas lost a distinguished
2 businesswoman and patron of the arts with the passing of Juanita
3 Lewis Miller on November 21, 2005, at the age of 93; and

4 WHEREAS, Born on February 14, 1912, in Kiowa, Oklahoma, Mrs.
5 Miller earned her bachelor's degree from the University of
6 Oklahoma; she taught English at a high school and at Kilgore Junior
7 College before being placed in charge of recreation and cultural
8 arts at a center for returning World War II service personnel in Hot
9 Springs, Arkansas; it was there that she met Henry S. Miller, Jr.,
10 whom she married in 1945; and

11 WHEREAS, After moving to Dallas in the 1940s, Mrs. Miller
12 helped her husband establish what would become one of the nation's
13 largest real estate companies; she went on to play a critical role
14 in the burgeoning Dallas arts scene, cofounding with her husband
15 the Dallas Civic Opera, now the Dallas Opera, in 1957 and founding
16 the Texas Women's Association for Symphony Orchestras, now the
17 Texas Association for Symphony Orchestras, in 1965; and

18 WHEREAS, Mrs. Miller further served as vice president and
19 board member of the Dallas Ballet, president and board member of the
20 Dallas Opera, board member of the Dallas Symphony Orchestra, and
21 president and board member of the Dallas Symphony Orchestra League;
22 moreover, she was a founding board member of the Dallas Theater
23 Center and served on the president's council for the Dallas Museum
24 of Art as well as on the board of the Dallas Museum of Art League;

2 WHEREAS, The City of Dallas also greatly benefited from Mrs.
3 Miller's commitment to philanthropy and public service, notably
4 through her work as zone chair for the American Red Cross and fund
5 drive chair for Community Chest; she was a charter member of the
6 Dallas Council on World Affairs and was appointed by the mayor of
7 Dallas to the cultural division of the Mayor's Commission on
8 International Development; and

9 WHEREAS, In recognition of her lifelong involvement in the
10 arts and her commitment to civic and educational causes, Mrs.
11 Miller was named Les Femmes du Monde's Woman of the Year in 1999;
12 her other recognitions include the Flora Award, the TACA Silver Cup
13 Award, and the Dallas Historical Society Award for Excellence in
14 the Arts; one of her proudest achievements was the Juanita Miller
15 Concerto Competition, a scholarship offered through the Texas
16 Association for Symphony Orchestras; and

17 WHEREAS, Although she is profoundly missed by family and
18 friends, Juanita Miller has left behind an exceptional legacy of
19 good works that will benefit generations of Texans for years to
20 come; now, therefore, be it

21 RESOLVED, That the House of Representatives of the 79th Texas
22 Legislature, 3rd Called Session, hereby pay tribute to the life of
23 Juanita Lewis Miller and extend sincere sympathy to the members of
24 her family: to her husband of more than 60 years, Henry S. Miller,
25 Jr.; to her children and their spouses, Vance Miller and Geraldine
26 Tincy Miller, Patsy Miller Donosky and David Donosky, Henry S.
27 Miller III and Angela Ahmadi Miller, and Jacqueline Miller Stewart

2 and her husband, Robert, Vaughn Miller and his wife, Dena, Gregory
3 Miller and his wife, Kim, Steve Donosky and his wife, Lissie, Janie

5 Sue Donosky, Kathy Miller Rabey and her husband, Tracy, Henry S.
