R E S O L U T I O N

1 WHEREAS, Pavillion Bank has served the citizens of Richardson
2 and North Dallas with the utmost distinction for more than 20 years,
3 and this dynamic financial institution expanded its vision for the
4 future by relocating to a state-of-the-art facility in October
5 2005; and

6 WHEREAS, Chartered as Pavillion National Bank in 1982, the
7 enterprise was formed by a group of investors who shared a common
8 vision of building a community-centered, neighborhood bank; and

9 WHEREAS, Pavillion National Bank opened its doors to the
10 public in January 1983 and, thanks to the efforts of its
11 knowledgeable and dedicated staff, board members, and officers, the

9 Storey, Rucie Odom, Hershel H. Pierce, Marshal W. Dooley, Tony
