- 9 Education and Economic Development Center, located in the "Little
- 10 Asia" section of East Dallas, offers job training, entrepreneur
- 11 development theory, and business assistance to local residents;
- 12 these two endeavors demonstrate how the chamber sustains and
- 13 nurtures business development by meeting the diverse needs of
- 14 chamber and community members; and
- 15 WHEREAS, Involvement in chamber committees affords an
- 16 excellent opportunity to network with other professionals while
- 17 promoting the chamber and its various services and programs; among
- 18 the chamber's current committees are groups concerned with the
- 19 Asian Trade District, business and economic development,
- 20 corporate/public relations, education, finance, international
- 21 affairs, strategic planning, and women in business; and
