

R E S O L U T I O N

1           WHEREAS, The history of the Lone Star State has been richly  
2 influenced by family farming and ranching, and the Haynes family of  
3 McMullen County has now been officially recognized as heirs to this  
4 proud tradition with the acceptance of the Donald Haynes and Son  
5 Ranch into the Texas Family Land Heritage Program; and

6           WHEREAS, The Family Land Heritage Program recognizes farms  
7 and ranches that have been in continuous agricultural operation by  
8 the same family for a century or more, and in reaching this  
9 remarkable milestone, the Haynes ranch has secured its stature in  
10 Texas ranching history; and

11           WHEREAS, Purchased by Ralph Franklin in the early 1880s, the  
12 5,000-acre property was originally a part of Confederate Scrip No.  
13 1497; Mr. Franklin and his family, including his wife, Minerva, and  
14 their 12 children, raised cattle on the land; and

15           WHEREAS, Over the ensuing years, the property was passed down  
16 through generations of Mr. Franklin's descendants, from his son,  
17 Tom, to his granddaughters, Rosemary Franklin Haynes and Charlie  
18 Ann Franklin Austin; Rosemary Haynes acquired her 884-acre share of  
19 the ranch in 1964, and together with her husband, Donald, she raised  
20 cattle and participated in soil conservation; today, she also  
21 raises coastal Bermuda grass on the land and continues a family  
22 tradition of agricultural excellence alongside her son, Donald  
23 Haynes, Jr., and her daughter, Mary Catherine Haynes Kessler; and

24           WHEREAS, The rewarding but challenging work of running a

1 sustainable agricultural operation is not only a valuable service  
2 to the community but a vital link to the rich and colorful history  
3 that has made the Lone Star State what it is today, and the Haynes  
4 family continues to contribute immeasurably to this fine tradition;  
5 now, therefore, be it

6         RESOLVED, That the House of Representatives of the 79th Texas  
7 Legislature, 3rd Called Session, hereby congratulate Rosemary  
8 Haynes and her children on the inclusion of the Donald Haynes and  
9 Son Ranch into the Texas Family Land Heritage Program and extend to  
10 them sincere best wishes for the future; and, be it further

11         RESOLVED, That an official copy of this resolution be  
12 prepared for the Haynes family as an expression of high regard by  
13 the Texas House of Representatives.
