

R E S O L U T I O N

1           WHEREAS, Memories of a life characterized by devotion to  
2 family, leadership in the community, and success in many endeavors  
3 may comfort the family and friends of Carole Opryshek of Baytown,  
4 who passed away on March 16, 2006, at the age of 68; and

5           WHEREAS, Born on January 2, 1938, in Baytown, Mrs. Opryshek  
6 was valedictorian of the Robert E. Lee High School Class of 1957 and  
7 went on to attend Lee College; after assuming ownership of her  
8 parents' real estate business in 1970, she soon became one of the  
9 most successful Realtors in the Baytown area; often called the  
10 "Dean of Real Estate," she received the *Baytown Sun's* Readers  
11 Choice award for favorite real estate agent four times; and

12           WHEREAS, A committed civic leader, Mrs. Opryshek gave  
13 generously of her time and talents in behalf of her beloved  
14 hometown; at the time of her passing, she was a director of the  
15 Baytown Chamber of Commerce and a member of the city's Long Range  
16 Planning Commission; she had also served on the Steering Committee  
17 for the city's 2020 Comprehensive Plan Update and the Planning and  
18 Zoning Commission; a trusted advisor to a number of the city's  
19 mayors over the years, she also served as district coordinator for  
20 former U.S. Representative Nick Lampson; moreover, she was named  
21 Volunteer of the Year in 1999 by the chamber of commerce and in 2000  
22 the *Baytown Sun* named her Citizen of the Year; and

23           WHEREAS, Her dedication to the community extended into many  
24 areas of advocacy; a great supporter of education, she served as

1 both a member and president of the Goose Creek School Board in the  
2 1960s and 1970s, and she was vice chair of the Friends of Lee  
3 College; her contributions to the local YMCA were numerous,  
4 including service as a board member and as director of the  
5 Partnership of Youth project, which provided scholarships for  
6 low-income families to utilize the YMCA; in 1997, she was honored as  
7 the Baytown YMCA Volunteer of the Year, and she was made a lifetime  
8 member on her retirement from the board; she also served on the  
9 board of the local chapter of the American Cancer Society; and

10 WHEREAS, An inspiration to her children, Mrs. Opryshek always  
11 made time for her family and especially enjoyed the company of her  
12 grandson, Steven; and

13 WHEREAS, Those who were privileged to know Carole Opryshek  
14 will long remember her wisdom, warmth, and enthusiasm, and Baytown  
15 will forever be a better place to live because of her passionate  
16 civic involvement; now, therefore, be it

17 RESOLVED, That the House of Representatives of the 79th Texas  
18 Legislature, 3rd Called Session, hereby pay tribute to the life of  
19 Carole Opryshek and extend sincere sympathy to the members of her  
20 family: to her daughter, Karla Opryshek Cernosek; to her son, Karl

22 to her brother, David Wilks; to her sister, Diane Wilks Gillette,
