3 Younger, Sr., on October 1, 2005, at the age of 90; and

WHEREAS, Born in McKinney on November 8, 1914, Mr. Younger

worked his way through Texas A&M University and graduated with a

degree in chemical engineering in 1937; in his first professional

job, he worked as a mud engineer for Baroid Sales Division, National

9 WHEREAS, Mr. Younger joined the United States Army in 1941 as

a chemical warfare officer; he subsequently served for 31 months as

the executive officer of the port of Khorramshahr, in what is now

Iran, supervising the shipment of wartime supplies to the Soviet

Union; by the time he was discharged in 1945, he had earned a Bronze

14 Star and attained the rank of lieutenant colonel; and

WHEREAS, Following his return to civilian life, Mr. Younger

moved his family to West Texas and joined the Western Company;

within six years he had become vice president in charge of wire line

services and general manager for research; in 1957, he struck out on

19 his own as an independent oil operator and real estate developer;

21 WHEREAS, While achieving notable success in the business

22 world, Mr. Younger also worked diligently in behalf of his

community; he was a founding director and chairman of High Sky

Girls' Ranch, a member of the founding board of the Petroleum Basin

- 1 Museum, Library, and Hall of Fame, a two-term trustee for the
- 2 Midland Independent School District, a president of the Midland
- 3 Chamber of Commerce, a vice chairman of the Community Chest, and a
- 4 member of the Exchange Club; in addition, he was a board chairman
- 5 and longtime fund-raiser for Midland Presbyterian Homes and an
- 6 active and honorary member of the Abell-Hanger Foundation Board of
- 7 Trustees; and
- 8 WHEREAS, An ardent Aggie, he served as a member of the
- 9 President's Council at Texas A&M and as president of the Former
- 10 Students Association, which established the Century Club under his
- 11 leadership; he was also instrumental in the creation of the
- 12 university's Institute of Nautical Archeology; and
- WHEREAS, Among the many accolades received by Mr. Younger
- 14 were the Golden Deeds award from the Exchange Club, the Top Hand
- 15 award from the Permian Basin Petroleum Association, the Trustee of
- 16 the Year award from both the Texas and National Associations of
- 17 Homes for the Aged, and the Distinguished Alumnus award from Texas
- 18 A&M; moreover, the Younger Center, which specializes in the care of
- 19 patients with Alzheimer's disease, was named in his honor at Manor
- 20 Park; and
- 21 WHEREAS, Mr. Younger married Charlene Smith on April 10,
- 22 1939, in Lake Charles, Louisiana, and the couple enjoyed a loving
- 23 marriage that spanned more than six decades until her passing;
- 24 together with several other families, they formed Memorial
- 25 Christian Church, Disciples of Christ, in 1954, and Mr. Younger
- served the congregation for many years as an elder; and
- 27 WHEREAS, John Younger leaves an extraordinary legacy in the

- 1 programs and institutions he helped bring to fruition and in the
- 2 countless small miracles he worked, often anonymously, for ordinary
- 3 individuals; his life was rich in purpose, accomplishments, family,
- 4 and friends, and his memory will be forever cherished by all who
- 5 shared in the warmth of his friendship and affection; now,
