- 3 12, 2006, at the age of 84; and
- WHEREAS, Born in Fort Worth on August 8, 1921, Mr. Hinckley
- 5 was raised in Waco, Dallas, and Houston; after receiving his
- 6 diploma from San Jacinto High School in the Bayou City, he spent
- 7 three years in Alaska, taking on the responsibility for a placer
- 8 gold-mining operation established in Nome by his father, a
- 9 U.S. marshal in the Territory of Alaska; during the winters, he
- 10 attended the University of Alaska in Fairbanks; and
- 11 WHEREAS, Shortly after the United States entered World War
- 12 II, Mr. Hinckley joined the Army Air Corps; he served in the
- 13 military for nearly four years, with his last assignments taking
- 14 him to New Guinea and the Netherlands East Indies as a member of the
- 15 5th Air Force; and
- 16 WHEREAS, Honorably discharged, he continued his education at
- 17 The University of Texas, where he graduated with a bachelor of
- 18 business administration degree; Mr. Hinckley subsequently enjoyed
- 19 a distinguished 37-year career with Houston Lighting & Power
- 20 Company, attaining the office of group vice president of external
- 21 relations; and
- WHEREAS, While handling the myriad demands of his corporate
- 23 post, this esteemed Texan also gave generously of his time and
- 24 talents to a number of civic groups, worthy causes, and industry

- organizations; he was involved with Baylor College of Medicine, the
- 2 March of Dimes, the United Fund, Trees for Main Street, Clean
- 3 Houston, the Houston and East Texas Chambers of Commerce, the
- 4 Better Business Bureau, the Houston Convention Council, and Edison
- 5 Electric Institute; and
- WHEREAS, In retirement, Mr. Hinckley moved with his wife,
- 7 June, to the Texas Hill Country, where they divided their time
- 8 between a lakeside home and a hilltop residence in Austin; on
- 9 numerous occasions, the couple traveled abroad with the Flying
- 10 Longhorns; a life member of the Texas Exes, Mr. Hinckley also took
- 11 advantage of lectures and continuing education programs at UT and
- 12 supported the school's athletic programs as a spectator and donor;

- 14 WHEREAS, A deeply admired role model for all who knew him, Ken
- 15 Hinckley embodied the best values of a generation that defended
- 16 freedom at tremendous personal cost and that built a stronger, more
- 17 prosperous society on the foundation laid by their forebears;
- 18 preceded in death by his beloved wife of 57 years, he will forever
- 19 be remembered with warm affection by those whose hearts and lives he
- 20 touched; now, therefore, be it
