9 University in Warrensburg; a young sailor, Bill Ricketts, enrolled

21 Ricketts took a job at Abilene Christian University; her
22 association with the institution continues to this day; since 1972,
23 she has ably served as secretary for State Representative Bob
24 Hunter, senior vice president emeritus of ACU; throughout her

1 career, she has adhered to the highest standards of professionalism
2 and earned the lasting respect and admiration of her employer and
3 colleagues alike; and

4 WHEREAS, Committed to a range of worthy causes, she has been a
5 valued member of the Abilene Business Women's Association, Western
6 Horizons Chapter, lending her talents to the Junior Miss
7 Scholarship Program; she also serves her congregation at Hillcrest
