## RESOLUTION

1 WHEREAS, Colonel Glenn E. Ballard is retiring from the United 2 States Army in June 2006, and throughout his 29-year career in the 3 military he has rendered exceptional service to this country; and WHEREAS, Since September 2001, Colonel Ballard has commanded 4 the 12th Battalion (CAS3), 6th Brigade, 95th Division (IT); in that 5 6 post, he has overseen Combined Arms and Services Staff School (CAS3) instruction in nine states: Texas, New Mexico, Oklahoma, 7 Arkansas, Louisiana, Missouri, Kansas, Nebraska, and Iowa; and 8 WHEREAS, This distinguished officer joined the army in 1970 9 and received a commission the following year as a first lieutenant; 10 11 assigned as an occupational therapist to the Medical Specialist 12 Corps, he served at Letterman Army Medical Center in San Francisco 13 and at Madigan Army Medical Center in Tacoma, Washington; and 14 WHEREAS, After a short break from active service, he joined the 3457th Medical Training Center in Houston to learn military 15 teaching techniques and to supervise the training at the 91C 16 school; he then worked as an S-3 assistant at the 330th General 17 18 Hospital in Memphis, Tennessee, before taking a second break from active duty; and 19 WHEREAS, Colonel Ballard reenlisted and received a promotion 20 21 to major in 1989; his new assignment took him to the 94th General 22 Hospital in the Dallas area, where he served as the hospital's movement officer until 1997; in 1991 he deployed to Germany, when 23 the hospital was activated in support of Operation Desert Storm, 24

- and in 1992 he was promoted to lieutenant colonel; and
- WHEREAS, Certified as a CAS3 instructor in 1997, Colonel
- 3 Ballard became the training director for Arkansas one year later
- 4 and held that post until assuming his present office; and
- 5 WHEREAS, A graduate of The University of Texas Medical
- 6 Branch, where he earned a B.S. in the Occupational Therapy School,
- 7 Colonel Ballard also holds an M.A. in behavioral science from the
- 8 University of Houston at Clear Lake; and
- 9 WHEREAS, Glenn Ballard is the husband of Paige Rhinehart and
- 10 the father of a son, Jason; and
- 11 WHEREAS, The awards and decorations conferred on Colonel
- 12 Ballard include the Meritorious Service Medal, Army Commendation
- 13 Medal with four Oak Leaf Clusters, National Defense Service Ribbon,
- 14 Armed Forces Reserve Medal, Army Service Ribbon, and Army Overseas
- 15 Service Ribbon; and
- 16 WHEREAS, During Colonel Ballard's tenure as commander of the
- 17 12th Battalion, he has been instrumental in shaping one of the
- 18 army's most respected training programs for staff officers, and
- 19 through his deep devotion to this country and his consummate
- 20 professionalism, he has embodied the highest ideals of the United
- 21 States armed forces; now, therefore, be it
- 22 RESOLVED, That the House of Representatives of the 79th Texas
- 23 Legislature, 3rd Called Session, hereby honor Colonel Glenn E.
- 24 Ballard on the occasion of his retirement from the United States
- 25 Army and extend to him deep appreciation for his exemplary military
