

R E S O L U T I O N

1 WHEREAS, The Rogelio Sanchez State Jail is celebrating its
2 10th anniversary of providing for the safety and protection of the
3 citizens of El Paso and Texas in 2006; and

4 WHEREAS, Dedicated on April 11, 1996, and accredited by the
5 American Correctional Association, this 1,100-bed facility for
6 male offenders has become one of the exemplary units of the Texas
7 Department of Criminal Justice; in addition to its participation in
8 community work projects, the jail offers inmates numerous
9 educational and rehabilitative opportunities, including classes
10 teaching literacy, parenting, and career and technology skills,
11 family and substance-abuse support groups, and other programs; and

12 WHEREAS, The Sanchez State Jail was initially overseen by
13 Gilbert Campuzano, its first senior warden, and is currently under
14 the direction of William E. Walker; it employs nearly 300 area
15 Texans, and among its current staff are numerous personnel who were
16 assigned to the unit at its opening 10 years ago; those dedicated
