1 WHEREAS, The community of Daingerfield lost one of its most
2 admired citizens with the passing of Mary Sue Hill on February 14,
3 2006, at the age of 69; and

4 WHEREAS, A member of the Daingerfield City Council from May
5 6, 2000, until her resignation in January 2006, Mrs. Hill was deeply
6 committed to the people of her community and gave readily of her
7 time and talents in their behalf; in addition to holding public
8 office, she involved herself wholeheartedly in a number of other
9 community endeavors, always devoting her utmost efforts to the
10 cause at hand; and

11 WHEREAS, Sue Hill worked as a registered nurse at Titus
12 Regional Medical Center, Hospital in the Pines, and East Texas
13 Medical Center; she also served as a volunteer with the
14 Daingerfield-Lone Star Volunteer Ambulance Service for about six
15 years and then with Champion Emergency Medical Services; and

16 WHEREAS, Her affiliations included the Fellowship Baptist
17 Church in Daingerfield and the Daingerfield Eastern Star, of both
18 of which she was a valued member; and

19 WHEREAS, Originally from Alabama, Mrs. Hill was born in
20 Alabama City on August 12, 1936; her husband, James G. Hill, Sr.,
21 who was also engaged in many community activities, preceded her in
22 death; and

23 WHEREAS, Held in the highest esteem and affection by her
24 fellow citizens, Sue Hill touched many lives and tirelessly worked

1 to advance the well-being of her community; her memory will be
2 forever cherished by those who shared in the warmth of her love and
3 friendship; now, therefore, be it

4 RESOLVED, That the House of Representatives of the 79th Texas
5 Legislature, 3rd Called Session, hereby pay tribute to the life of
6 Mary Sue Hill and extend sincere sympathy to the members of her
7 family: to her children, James Hill, Jr., Bobby Hill, David Phillip
8 Pope II, Venita Stewart, and Jamie Calender; to her foster daughter
9 and son-in-law, Nita and Chris McCord; to her grandchildren, Bryce
10 Kelley Stewart, Melissa Hill, John Winston Hill, David James Pope,
11 Marsha Jeanette Pope, Jimmy Lee Pope, Tyler Kaine Calender, and
12 Christopher James Calender; to her great-grandchildren; to her
13 mother-in-law, Myrtis McDuffie Reid; to her sister-in-law and
14 brother-in-law, Peggy and Cloyce Tyner; and to her other relatives
