

1 SENATE CONCURRENT RESOLUTION

2 WHEREAS, The Greater Houston Chapter of the Texas Society of  
3 Professional Engineers named James D. Pitcock the 2006 Engineer of  
4 the Year at the annual Engineer of the Year banquet on February 24,  
5 2006; and

6 WHEREAS, A native of Tulsa, Oklahoma, and a 1950 graduate of  
7 Texas A&M University, Doug Pitcock cofounded Williams Brothers  
8 Construction Company, Incorporated, in 1955, and today he is the  
9 owner, chairman of the board, and chief executive officer of the  
10 company, which grosses more than \$550 million annually and employs  
11 over 2,400 people; and

12 WHEREAS, A recognized leader in the transportation industry,  
13 specializing in highway design and construction, Mr. Pitcock has  
14 served as the chair of the Houston Chamber of Commerce  
15 transportation committee, the twice-elected president of the Texas  
16 Highway Branch of the Associated General Contractors, and the  
17 national president of the Associated General Contractors of  
18 America; and

19 WHEREAS, This longtime Houston resident was appointed by  
20 President Gerald Ford to serve on the National Transportation  
21 Policy Study Commission; in addition, he was selected by Governor  
22 Preston Smith to serve on the Texas State Board of Registration for  
23 Professional Engineers and was named to the Texas 2000 Commission  
24 and the Texas Deep Water Port Authority Commission by Governor

1 William P. Clements; and

2 WHEREAS, Mr. Pitcock has been further recognized with his  
3 induction into the Texas Good Roads/Transportation Association's  
4 Hall of Honor and the Texas A&M Texas Transportation Institute Hall  
5 of Honor; moreover, he was named one of the Top 100 Design and  
6 Construction Professionals of the 20th Century; and

7 WHEREAS, In all his endeavors, Mr. Pitcock has enjoyed the  
8 love and support of his wife, Eleanor Hall "Puddie" Pitcock, and his  
9 record of success and achievement can be seen throughout the state  
10 and nation; now, therefore, be it

11 RESOLVED, That the 79th Legislature of the State of Texas,  
12 3rd Called Session, hereby congratulate James D. Pitcock, Jr., on  
13 being named 2006 Engineer of the Year and honor him for his  
14 outstanding professional career; and, be it further

16 prepared for Mr. Pitcock as an expression of high regard by the  
17 Texas Senate and House of Representatives.
