#### **BILL ANALYSIS**

H.B. 1478 By: Wong Land & Resource Management Committee Report (Unamended)

#### **BACKGROUND AND PURPOSE**

Eminent domain is a sometimes controversial power of government whereby private property is taken for public use, but only in exchange for "adequate" compensation. There is an apparent contradiction in the law today concerning municipal management districts and their power of eminent domain.

The purpose of H.B. 1478 is to correct this legal contradiction and deny the power of eminent domain to 21 municipal management and improvement districts in Harris County.

### **RULEMAKING AUTHORITY**

It is the opinion of the committee that this bill does not expressly grant any additional rulemaking authority to any state officer, department, agency or institution.
