- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 4 SECTION 1. Subchapter C, Chapter 702, Occupations Code, is
- 5 amended by adding Section 702.107 to read as follows:
- 6 Sec. 702.107. SALES TAX PERMIT; PROOF OF REGISTRATION
- 7 REQUIRED. (a) A health spa operator shall submit to the comptroller
- 8 <u>a copy of the operator's certificate of registration at the time the</u>
- 9 operator applies for a sales tax permit.
- 10 (b) The comptroller may not issue a sales tax permit to a
- 11 health spa operator who fails to comply with this section. The
- 12 secretary of state shall assist the comptroller in determining
- 13 whether a business is a health spa under this chapter.
- SECTION 2. Section 702.151, Occupations Code, is amended to
- 15 read as follows:
- Sec. 702.151. SECURITY REQUIRED. (a) Except as provided by
- 17 Subchapter E, the secretary of state may not issue a health spa
- 18 operator's certificate of registration to an applicant unless the
- 19 applicant files a surety bond, or posts other security as
- 20 prescribed by the secretary, in the amount prescribed by the
- 21 secretary under Subsection (b) [of \$20,000].
- 22 (b) The secretary of state shall prescribe the amount of
- 23 security required for an applicant in the amount determined
- 24 sufficient by the secretary to protect the health spa's total

- 1 membership. The amount may not be less than \$20,000 or more than
- 2 \$50,000.
- 3 SECTION 3. Subchapter D, Chapter 702, Occupations Code, is
- 4 amended by adding Section 702.158 to read as follows:
- 5 Sec. 702.158. REVIEW OF SECURITY AMOUNT. (a) At least once
- 6 every three years, the secretary of state shall review the amount of
- 7 security a health spa operator is required to post under Section
- 8 702.151 to determine whether the amount is sufficient to protect
- 9 the health spa's total membership. The secretary may increase the
- 10 amount required if the secretary determines that the increase is
- 11 necessary to protect that membership but may not increase the
- amount above the maximum amount allowed under Section 702.151(b).
- (b) The secretary of state may adopt procedures necessary to
- 14 implement this section, including:
- (1) establishing a schedule to review the amount of
- security posted by each health spa operator; and
- 17 (2) requiring each health spa operator to submit
- 18 periodically a written statement of the health spa's total
- 19 membership.
- SECTION 4. Section 702.202, Occupations Code, is amended to
- 21 read as follows:
- Sec. 702.202. QUALIFICATIONS FOR EXEMPTION. A certificate
- 23 holder may apply for an exemption under Section 702.201 if:
- 24 (1) the certificate holder does not require, or
- 25 solicit or offer a plan or program that requires, a health spa
- 26 consumer to:
- 27 (A) execute a membership contract for a term that

- 1 exceeds 31 days;
- 2 (B) execute a note or retail installment
- 3 contract;
- 4 (C) authorize a draw or other recurring debit on
- 5 a financial institution in favor of the certificate holder or the
- 6 certificate holder's assignee;
- 7 (D) pay an initiation fee or other fee, not
- 8 including monthly dues; or
- 9 (E) prepay for a term that exceeds 31 days; or
- 10 (2) the certificate holder <u>submits a sworn statement</u>
- 11 every three years with the secretary of state stating that the
- 12 certificate holder:
- 13 (A) has <u>assets based on net book value that</u>
- 14 <u>exceed \$50,000 per registered location</u> [continuously owned and
- 15 operated a health spa in this state for not less than five years at
- 16 the same location]; [and]
- 17 (B) has operated under substantially the same
- ownership or management for at least five years; and
- 19 <u>(C)</u> has not been the subject of a complaint
- 20 relating to the closing of a health spa owned by the certificate
- 21 holder or the failure of a health spa owned by the certificate
- 22 holder to open that has been initiated or filed by a member of the
- 23 health spa with a governmental authority in this state.
- SECTION 5. Section 702.301, Occupations Code, is amended to
- 25 read as follows:
- Sec. 702.301. GENERAL REQUIREMENTS. (a) A contract:
- 27 (1) must be:

- 1 (A) in writing; and
- 2 (B) signed by the purchaser; [and]
- 3 (2) must state the proposed opening date of the health 4 spa that is the subject of the contract, if the health spa is not
- 5 open on the contract date; and
- 6 (3) must include the health spa operator's certificate
- 7 of registration number or an identification number as provided by
- 8 Subsection (b).
- 9 (b) The secretary of state shall adopt procedures for the
- 10 <u>issuance of an identification number that may be used in a contract</u>
- 11 for purposes of Subsection (a) by health spas with more than one
- 12 <u>location in this state.</u>
- (c) [(b)] A contract under Subsection (a) constitutes the
- 14 entire agreement between the seller and purchaser.
- 15 SECTION 6. Section 702.304, Occupations Code, is amended to
- 16 read as follows:
- 17 Sec. 702.304. CANCELLATION AND REFUND NOTICE. (a) Except
- 18 as provided by Subsection (b), a [A] contract must state in at
- 19 least 10-point type that is boldfaced, capitalized, underlined, or
- 20 otherwise conspicuously distinguished from surrounding written
- 21 material:
- 22 (1) "NOTICE TO PURCHASER: DO NOT SIGN THIS CONTRACT
- 23 UNTIL YOU READ IT OR IF IT CONTAINS BLANK SPACES."
- 24 (2) "IF YOU DECIDE YOU DO NOT WISH TO REMAIN A MEMBER
- 25 OF THIS HEALTH SPA, YOU MAY CANCEL THIS CONTRACT BY MAILING TO THE
- 26 HEALTH SPA BY MIDNIGHT OF THE THIRD BUSINESS DAY AFTER THE DAY YOU
- 27 SIGN THIS CONTRACT A NOTICE STATING YOUR DESIRE TO CANCEL THIS

1	CONTRACT. THE WRITTEN NOTICE MUST BE MAILED BY CERTIFIED MAIL TO TH

4	(3) "IF THE HEALTH SPA GOES OUT OF BUSINESS AND DOES

6	ARE ENROLLED OR IF THE HEALTH SPA MOVES MORE THAN 10 MILES FROM T		
7	FACILITY IN WHICH YOU ARE ENROLLED, YOU MAY:		
8	(A) CANCEL THIS CONTRACT BY MAILING BY CERTIFIED		
9	MAIL A WRITTEN NOTICE [TO THE HEALTH SPA] STATING YOUR DESIRE TO

- 6 (b) A health spa operator is required to include the
- 7 statement under Subsection (a)(3)(B) in a contract only if the

- SECTION 7. Subchapter I, Chapter 702, Occupations Code, is
- amended by adding Section 702.404 to read as follows:
- 12 Sec. 702.404. INFORMATION REQUIRED IN ADVERTISEMENT. A
- 13 health spa operator may not advertise in any print or electronic
- 14 medium unless the advertisement includes the health spa operator's
- 15 certificate of registration number or an identification number
- issued as provided by Section 702.301(b).
- 17 SECTION 8. The heading to Section 702.452, Occupations
- 18 Code, is amended to read as follows:
- 19 Sec. 702.452. NOTICE REQUIREMENT BEFORE [OF CLOSED] HEALTH
- 20 SPA CLOSING.
- 21 SECTION 9. Section 702.452, Occupations Code, is amended by
- 22 amending Subsections (a) and (b) and adding Subsection (f) to read
- 23 as follows:
- 24 (a) At least 30 days before [Not later than the third day
- 25 after] the date a health spa is scheduled to close or relocate
- 26 [closed], the certificate holder shall contemporaneously:
- 27 (1) post, inside and outside each entrance to [at] the

- health spa [location], a notice stating:
- 2 (A) the date [that] the health spa is scheduled
- 3 to close or relocate [closed];
- 4 (B) that a member of the health spa may, not later
- 5 than the 90th day after the date the health spa closes or relocates
- 6 [notice is first posted], file with the secretary of state a claim
- 7 to recover actual financial loss suffered by the member as a result
- 8 of the health spa closing; and
- 9 (C) the procedures for perfecting a security
- 10 claim; and
- 11 (2) notify the secretary of state <u>in writing</u> of the
- 12 health spa closing or relocation and the date that the notice was
- 13 first posted.
- 14 (b) The notice posted under Subsection (a)(1) must be:
- 15 (1) at least 8-1/2 by 11 inches in size; and
- 16 (2) [posted in a place that is readily accessible to
- 17 the general public during the former operating hours of the health
- 18 spa; and
- 19 $\left[\frac{(3)}{2}\right]$ posted continuously for at least 30 $\left[\frac{14}{2}\right]$ days.
- 20 (f) The notice required under Subsection (a) is not required
- 21 <u>in the case of a fire, flood, or act of God that is not within the</u>
- 22 reasonable control of a health spa.
- SECTION 10. Sections 702.203 and 702.204, Occupations Code,
- 24 are repealed.
- 25 SECTION 11. Not later than January 1, 2006, the comptroller
- of public accounts shall provide the secretary of state with the
- 27 name and address of each person that holds a sales tax permit issued

- 1 before September 1, 2005, and provides services that may require
- 2 the person to hold a health spa operator's certificate of
- 3 registration under Chapter 702, Occupations Code.
- 4 SECTION 12. This Act takes effect September 1, 2005.
