A BILL TO BE ENTITLED

1	AN ACT
2	relating to requiring the registration of certain containers of
3	alcoholic beverages; providing criminal penalties.
4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Title 4, Alcoholic Beverage Code, is amended by
6	adding Chapter 111 to read as follows:
7	CHAPTER 111. KEG REGISTRATION
8	Sec. 111.01. DEFINITION. In this chapter, "keg" means a
9	container that is designed to:
10	(1) hold four gallons or more of an alcoholic
11	beverage; and
12	(2) dispense the alcoholic beverage directly from the
13	container for purposes of consumption.
14	Sec. 111.02. KEG REGISTRATION LABEL REQUIRED. (a) A
15	license or permit holder may not sell an alcoholic beverage in a keg
16	for off-premises consumption unless the license or permit holder
17	affixes a keg registration label to the keg before the purchaser
18	takes possession of the keg.
19	(b) The keg registration label must include:
20	(1) a keg registration number;
21	(2) the name, address, telephone number, and license
22	or permit number of the license or permit holder; and
23	(3) any other information required by the commission.
24	(c) The commission shall prescribe and furnish keg

1	registration labels.
2	Sec. 111.03. KEG REGISTRATION DECLARATION AND RECEIPT FORM
3	REQUIRED. (a) Before a license or permit holder sells an alcoholic
4	beverage in a keg for off-premises consumption, the license or
5	permit holder shall require the purchaser to complete a keg
6	registration declaration and receipt form.
7	(b) The keg registration declaration and receipt form must
8	<pre>contain:</pre>
9	(1) the name and address of the purchaser;
10	(2) the keg registration number;
11	(3) the date and time of the purchase;
12	(4) the form of identification presented by the
13	<pre>purchaser;</pre>
14	(5) a statement signed by the purchaser indicating
15	that the purchaser:
16	(A) is 21 years of age or older;
17	(B) does not intend to allow persons under 21
18	years of age to consume the alcoholic beverage purchased; and
19	(C) will not remove or obliterate or allow the
20	removal or obliteration of the registration label affixed to the
21	keg; and
22	(6) any other information required by the commission.
23	(c) A purchaser who obtains alcoholic beverages in more than
24	one keg from a license or permit holder on the same date in a single
25	transaction may complete one keg registration declaration and
26	receipt form for all kegs purchased in the single transaction. In a
27	single transaction each keg may be listed on the same keg

- 1 registration declaration and receipt form.
- 2 (d) The license or permit holder shall verify the
- 3 information provided by the purchaser under Subsection (b)(1) with
- 4 a form of identification as prescribed by commission rule.
- 5 (e) The commission shall prescribe and furnish the keg
- 6 registration declaration and receipt form required by this section.
- 7 Sec. 111.04. RECORDKEEPING. (a) A license or permit holder
- 8 shall maintain for a period of one year an accurate record of all
- 9 keg registration declaration and receipt forms and other
- 10 documentation relating to the license or permit holder's sale of an
- alcoholic beverage in a keg for off-premises consumption, including
- 12 the keg registration label, at the place of business designated in
- 13 the license or permit.
- 14 (b) The license or permit holder shall make the records
- 15 relating to the sale of an alcoholic beverage in a keg open to
- 16 <u>inspection</u> by the commission or law enforcement officers at
- 17 reasonable dates and times.
- 18 Sec. 111.05. REMOVAL OF KEG REGISTRATION LABEL PROHIBITED.
- 19 A person other than the license or permit holder who sold the
- 20 alcoholic beverage in the keg may not remove, alter, deface, or
- 21 <u>obliterate the keg registration label affixed to the keg.</u>
- Sec. 111.06. TRANSFER OF REGISTERED KEG. (a) Except as
- 23 <u>authorized by the commission, a person may not transfer possession</u>
- of a registered keg to another person.
- 25 (b) This section does not apply to the return of the
- 26 registered keg to the license or permit holder.
- Sec. 111.07. RETURN OF KEG. (a) On the return of a

- 1 registered keg by a purchaser, the license or permit holder shall:
- 2 (1) remove the keg registration label from the keg;
- 3 and
- 4 (2) indicate the return of the keg on the keg
 5 registration declaration and receipt form.
- 6 (b) If a keg is returned without a keg registration label or
 7 with a keg registration label that has been altered, defaced, or
 8 obliterated, the license or permit holder shall report the name of
 9 the person who purchased the keg to the commission and the local law
 10 enforcement agency.
- Sec. 111.08. CRIMINAL OFFENSES. (a) A person other than a

 license or permit holder commits an offense if the person possesses

 a keg containing an alcoholic beverage that does not have a keg

 registration label affixed to the keg.
- (b) A person commits an offense if the person removes,
 alters, defaces, or obliterates the keg registration label affixed
 to a keg in violation of this chapter.
- 18 (c) An offense under this section is a Class C misdemeanor.
- Sec. 111.09. DEFENSE. It is an exception to the application of Section 111.08 if the keg was stolen from the purchaser and the purchaser reported the theft to the local law enforcement agency
- 22 within 24 hours of the theft.
- SECTION 2. (a) The Texas Alcoholic Beverage Commission shall adopt all rules, forms, and labels necessary to implement Chapter 111, Alcoholic Beverage Code, as added by this Act, not later than June 1, 2006.
- 27 (b) A license or permit holder authorized to sell alcoholic

- 1 beverages is not required to comply with the requirements of
- 2 Chapter 111, Alcoholic Beverage Code, as added by this Act, before
- 3 June 1, 2006.
- 4 SECTION 3. This Act takes effect September 1, 2005.
