department shall disclose to a criminal justice agency information

contained in its files and records regarding whether a named

individual or any individual named in a specified list is licensed

to any other individual whether a named individual or any

- 1 or license holder on request and the payment of a reasonable fee.
- 2 <u>(c)</u> The department shall notify a license holder of any 3 request that is made for information relating to the license holder 4 under this section and provide the name of the [person or] agency 5 making the request.
- 6 (d) This section does not prohibit the department from 7 making public and distributing to the public at no cost lists of 8 individuals who are certified as qualified handgun instructors by 9 the department.
- SECTION 2. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this Act takes effect September 1, 2005.
