## A BILL TO BE ENTITLED

- 2 relating to regulation of motor carriers transporting household
- 3 goods.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 643.051, Transportation Code, is amended
- 6 to read as follows:
- 7 Sec. 643.051. REGISTRATION REQUIRED. (a) A motor carrier
- 8 may not operate a commercial motor vehicle, as defined by Section
- 9 548.001, or a tow truck on a road or highway of this state unless the
- 10 carrier registers with the department under this subchapter.
- 11 (b) A motor carrier may not operate a vehicle, regardless of
- 12 size of the vehicle, to transport household goods for compensation
- 13 unless the carrier registers with the department under this
- 14 subchapter.
- 15 SECTION 2. Section 643.153(b), Transportation Code, is
- 16 amended to read as follows:
- 17 (b) The department may adopt rules necessary to ensure that
- 18 a customer of a motor carrier transporting household goods is
- 19 protected from deceptive or unfair practices and unreasonably
- 20 hazardous activities. The rules must:
- 21 (1) establish a formal process for resolving a dispute
- 22 over a fee or damage;
- 23 (2) require a motor carrier to indicate clearly to a
- 24 customer whether an estimate is binding or nonbinding and disclose

- 1 the maximum price a customer could be required to pay;
- 2 (3) create a centralized process for making complaints
- 3 about a motor carrier that also allows a customer to inquire about a
- 4 carrier's complaint record; and
- 5 (4) require a motor carrier transporting household
- 6 goods to list a place of business with a street address in this
- 7 state and the carrier's registration number issued under this
- 8 article in any print advertising published in this state[+
- 9 [<del>(5) require motor carriers that are required to</del>
- 10 register under Subsection (c) to file proof of cargo insurance in
- 11 amounts to be determined by the department that do not exceed the
- 12 amount required for a motor carrier transporting household goods
- 13 under federal law and allow alternative evidence of financial
- 14 responsibility, through surety bonds, letters of credit, or other
- 15 means satisfactory to the department, for contractual obligations
- 16 to customers that do not exceed \$5,000 aggregate loss or damage to
- 17 total cargo shipped at any one time;
- 18 [(6) require motor carriers that are required to
- 19 register under Subsection (c) to conspicuously advise consumers
- 20 concerning limitation of any carrier liability for loss or damage
- 21 as determined under Subdivision (7); and
- 22 [(7) determine reasonable provisions governing
- 23 limitation of liability for loss or damage of motor carriers
- 24 required to register under Subsection (c), not to exceed 60 cents
- 25 per pound per article].
- SECTION 3. Section 643.155(c), Transportation Code, is
- 27 amended to read as follows:

- 1 (c) The committee shall [+
- $[\frac{1}{2}]$  examine the rules adopted by the department under
- 3 Sections 643.153(a) and (b) and make recommendations to the
- 4 department on modernizing and streamlining the rules[+
- 5 [(2) conduct a study of the feasibility and necessity
- 6 of requiring any vehicle liability insurance for household goods
- 7 carriers required to register under Section 643.153(c); and
- 8 [(3) recommend a maximum level of liability limitation
- 9 under Section 643.153(b)(7) that does not exceed 60 cents per
- 10 pound].
- 11 SECTION 4. Section 643.252(a), Transportation Code, is
- 12 amended to read as follows:
- 13 (a) The department may suspend or revoke a registration
- 14 issued under this chapter or place on probation a motor carrier
- whose registration is suspended if a motor carrier:
- 16 (1) fails to maintain insurance or evidence of
- financial responsibility as required by Section 643.101(a), (b),
- 18 (c), or (d) [<del>or 643.153(b)</del>];
- 19 (2) fails to keep evidence of insurance in the cab of
- 20 each vehicle as required by Section 643.103(b);
- 21 (3) fails to register a vehicle requiring
- 22 registration;
- 23 (4) knowingly provides false information on any form
- 24 filed with the department under this chapter; or
- 25 (5) violates a rule adopted under Section 643.063.
- 26 SECTION 5. Sections 643.253(a), (b), and (e),
- 27 Transportation Code, are amended to read as follows:

- 1 (a) A person commits an offense if the person fails to:
- 2 (1) register as required by Subchapter B [<del>or Section</del>
- 3 <del>643.153(c)</del>];
- 4 (2) maintain insurance or evidence of financial
- 5 responsibility as required by Subchapter C [or Section 643.153]; or
- 6 (3) keep a cab card in the cab of a vehicle as required
- 7 by Section 643.059.
- 8 (b) A person commits an offense if the person solicits the
- 9 transportation of household goods for compensation and is not
- 10 registered as required by Subchapter B [or Section 643.153].
- (e) An offense under Subsection (b) or (d) is a misdemeanor
- 12 punishable by a fine of not less than \$200 or more than \$1,000 per
- 13 violation.
- 14 SECTION 6. Section 643.153(c), Transportation Code, is
- 15 repealed.
- SECTION 7. This Act takes effect September 1, 2005.
