4 (3) engages in conduct specified by Section 5 37.006(a)(2)(C) or (D), if the conduct is punishable as a felony.

6 SECTION 4. (a) Section 37.0011, Education Code, as added by 7 this Act, applies to punishment imposed under Subchapter A, Chapter 8 37, Education Code, on or after the effective date of this Act 9 regardless of when the conduct on which the punishment is based 10 occurred.

(b) Section 37.007(a), Education Code, as amended by this Act, applies to the expulsion of a student under that section on or after the effective date of this Act regardless of when the conduct on which the expulsion is based occurred.

15 SECTION 5. This Act takes effect immediately if it receives 16 a vote of two-thirds of all the members elected to each house, as 17 provided by Section 39, Article III, Texas Constitution. If this 18 Act does not receive the vote necessary for immediate effect, this 19 Act takes effect September 1, 2005.
