13	(2) a Lloyd's plan;
14	(3) an eligible surplus lines insurer; or
15	(4) a reciprocal or interinsurance exchange.
16	Sec. 542.252. DISCLOSURE OF CERTAIN INFORMATION BY INSURER.
17	Not later than the 30th day after the date an insurer receives a
18	request from a third-party claimant whose claim may be covered by
19	liability insurance issued by the insurer, the insurer shall
20	provide to the third-party claimant:
21	(1) a copy of each insurance policy issued by the
22	insurer that provides liability coverage to an insured who may be
23	liable for the claimant's damages, including excess or umbrella

1	(2) a statement, under oath, of a corporate officer of
2	the insurer or the insurer's claims manager or superintendent that
3	includes, for each of those policies:
4	(A) the name of the insurer issuing the policy;
5	(B) the name of each named insured under the
6	policy;
7	(C) the limits of the liability coverage under
8	the policy; and
9	(D) any policy or coverage defense that the
10	insurer reasonably believes is available to the insurer at the time
11	the statement is made.

13	OR INSURED'S AGENT. (a) An insured or the insured's insurance
14	agent, on written request of a third-party claimant or the
15	claimant's attorney, shall provide a written statement to the
16	requestor that includes the name of each insurer providing
17	liability coverage to the insured and a description of the coverage
18	provided to the insured and shall forward a copy of the request to
19	each of those insurers.
20	(b) Not later than the 30th day after the date an insurer
21	receives a request under this section, the insurer shall provide
22	the information prescribed by Subsection (a) to the third-party
23	claimant.
24	Sec. 542.254. AMENDMENT OF STATEMENT; PROVISION OF CERTAIN
25	ADDITIONAL INFORMATION. (a) An insurer or other person who
26	provides a statement under this chapter and who, after providing
27	the statement, discovers a fact required to be included in a

2	amended statement including that fact to the person who requested
3	the original statement.
4	(b) In addition to providing an amended statement under this
5	section, an insurer that discovers the existence of a policy
6	described by Section 542.252 that was not disclosed in the
7	statement provided under that section shall immediately provide a
8	copy of that policy to the third-party claimant.
9	SECTION 2. This Act takes effect immediately if it receives
10	a vote of two-thirds of all the members elected to each house, as
11	provided by Section 39, Article III, Texas Constitution. If this
12	Act does not receive the vote necessary for immediate effect, this

Act takes effect September 1, 2005.
