SECTION 2. Subchapter F, Chapter 1071, Occupations Code, is amended by adding Section 1071.264 to read as follows:

Sec. 1071.264. ADDITIONAL FEE. (a) In addition to the application fee required by Section 1071.252 for registration as a professional land surveyor, and in addition to the fee required by Section 1071.303 for renewal of registration, the applicant shall pay a fee of \$200.

21 (b) For each additional fee collected under this section, 22 <u>\$50 shall be deposited to the credit of the foundation school fund</u> 23 <u>and \$150 shall be deposited to the credit of the general revenue</u> 24 fund.

25 SECTION 3. (a) The change in law made by Section 1 of this 26 Act does not affect taxes imposed before the effective date of this 27 Act, and the law in effect before that date is continued in effect
