(e) If the vehicle is a commercial motor vehicle 1 2 transporting aggregates, as defined by Section 133.003, Natural Resources Code, or refuse, the load shall be covered and the 3 4 covering firmly secured at the front and back or shall be completely enclosed by the load-carrying compartment. For purposes of this 5 6 section, "commercial motor vehicle" means a motor vehicle, trailer, or semitrailer used primarily in the business of transporting 7 8 property.

9 SECTION 3. (a) The change in law made by this Act applies 10 only to an offense committed on or after the effective date of this 11 Act. For purposes of this section, an offense is committed before 12 the effective date of this Act if any element of the offense occurs 13 before that date.

(b) An offense committed before the effective date of this
Act is governed by the law in effect when the offense was committed,
and the former law is continued in effect for that purpose.
