5	SECTION 1. Subtitle H, Title 2, Health and Safety Code, is										
6	amended by adding Chapter 168 to read as follows:										
7	CHAPTER 168. CARE OF STUDENTS WITH DIABETES										
8	Sec. 168.001. DEFINITIONS. In this chapter:										
9	(1) "Diabetes management and treatment plan" means the										
10	document required by Section 168.002.										
11	(2) "Individualized health plan" means the document										
12	required by Section 168.003.										
13	(3) "Principal" includes the principal's designee.										
14	(4) "School" means a public elementary or secondary										
15	school. The term does not include an open-enrollment charter										
16	school established under Subchapter D, Chapter 12, Education Code.										
17	(5) "School employee" means a person employed by:										
18	(A) a school;										
19	(B) a local health department that assists a										
20	school under this chapter; or										
21	(C) another entity with which a school has										
22	contracted to perform its duties under this chapter.										
23	(6) "Unlicensed diabetes care assistant" means a

1 required by Section 168.005. 2 Sec. 168.002. DIABETES MANAGEMENT AND TREATMENT PLAN. (a) A diabetes management and treatment plan must be developed and 3 4 implemented for each student with diabetes who will seek care for 5 the student's diabetes while at school or while participating in a 6 school activity. The plan shall be developed by: 7 (1) the student's parent or quardian; and 8 (2) the physician responsible for the student's 9 diabetes treatment. 10 (b) A diabetes management and treatment plan must: (1) identify the health care services the student may 11 12 receive at school; (2) evaluate the student's ability to manage and level 13 14 of understanding of the student's diabetes; and 15 (3) be signed by the student's parent or guardian and 16 the physician responsible for the student's diabetes treatment. 17 (c) The parent or guardian of a student with diabetes who seeks care for the student's diabetes while the student is at school 18 19 shall submit to the school a copy of the student's diabetes management and treatment plan. The plan must be submitted to and 20 21 reviewed by the school: 22 (1) before or at the beginning of the school year; (2) on enrollment of the student, if the student 23 24 enrolls in the school after the beginning of the school year; or 25 (3) as soon as practicable following a diagnosis of 26 diabetes for the student.

- 1 individualized health plan is a coordinated plan of care designed
- 2 to meet the unique health care needs of a student with diabetes in

- 4 (b) An individualized health plan must be developed for each

7	ASSISTANT. (a) The Texas Diabetes Council shall develop								
8	guidelines, with the assistance of the following entities, for the								
9	training of unlicensed diabetes care assistants:								
10	(1) the department's School Health Program;								
11	(2) the American Diabetes Association;								
12	(3) the Juvenile Diabetes Research Foundation								
13	<pre>International;</pre>								
14	(4) the American Association of Diabetes Educators;								
15	(5) the Texas Nurses Association;								
16	(6) the Texas School Nurse Organization; and								
17	(7) the Texas Education Agency.								
18	(b) If a school nurse is assigned to a campus, the school								
19	nurse shall coordinate the training of school employees acting as								
20	unlicensed diabetes care assistants.								
21	(c) Training under this section must be provided by a health								
22	care professional with expertise in the care of persons with								
23	diabetes or by the school nurse. The training must be provided								
24	before the beginning of the school year or as soon as practicable

3	(d) The training must include instruction in:
4	(1) recognizing the symptoms of hypoglycemia and
5	hyperglycemia;
6	(2) understanding the proper action to take if the
7	blood glucose levels of a student with diabetes are outside the
8	target ranges indicated by the student's diabetes management and
9	treatment plan;
10	(3) understanding the details of a student's
11	individualized health plan;
12	(4) performing finger-sticks to check blood glucose
13	levels, checking urine ketone levels, and recording the results of
14	those checks;
15	(5) properly administering glucagon and insulin and
16	recording the results of the administration;
17	(6) recognizing complications that require seeking
18	emergency assistance; and
19	(7) understanding the recommended schedules and food
20	intake for meals and snacks for a student with diabetes, the effect
21	of physical activity on blood glucose levels, and the proper
22	actions to be taken if a student's schedule is disrupted.
23	(e) The school nurse or principal shall maintain a copy of
24	the training guidelines and any records associated with the
25	training.

- 13 student with diabetes in accordance with the student's
- 14 <u>individualized health plan.</u> If a school nurse is not assigned to
- 15 the campus or a school nurse is not available, an unlicensed

- (1) an unlicensed diabetes care assistant must have access to an individual with expertise in the care of persons with diabetes, such as a physician, a registered nurse, a certified diabetes educator, or a licensed dietitian; or

- (d) A school district may not restrict the assignment of a student with diabetes to a particular campus on the basis that the campus does not have the required unlicensed diabetes care assistants.
- (e) An unlicensed diabetes care assistant who assists a

 student's individualized health plan:
- (1) is not considered to be engaging in the practice of professional or vocational nursing under Chapter 301, Occupations

 Code, or other state law; and
- (2) is exempt from any applicable state law or rule
 that restricts the activities that may be performed by a person who
 is not a health care professional.

- 7 (2) administering insulin through the insulin
- 8 delivery system the student uses;
- 9 (3) treating hypoglycemia and hyperglycemia;

- this Act, applies beginning with the 2005-2006 school year.

SECTION 3. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this Act takes effect September 1, 2005.
