5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. Subchapter A, Chapter 130, Education Code, is
7	amended by adding Section 130.0034 to read as follows:
8	Sec. 130.0034. TUITION FOR REPEATED COURSES. (a) The
9	governing board of a public junior college district may charge a
10	student a higher rate of tuition than the tuition that would
11	otherwise be charged for a course in which the student enrolls if:
12	(1) the student has previously enrolled in the same
13	course or a course of substantially the same content and level two
14	or more times; and
15	(2) the student's enrollment in the course is not
16	included in the contact hours used to determine the junior
17	college's proportionate share of state appropriations under
18	Section 130.003.
19	(b) This section does not apply to a non-degree-credit
20	developmental course.
21	(c) The total amount of tuition charged to the student under
22	this section for the repeated course may not exceed the full cost of
23	instruction for the course with respect to the student.
24	SECTION 2. Section 135.52, Education Code, is amended to

1 read as follows: Sec. 135.52. FEES AND TUITION. (a) The board shall collect 2 3 tuition at the rates provided by law and registration fees. 4 (b) The board may charge a student a higher rate of tuition 5 than the tuition that would otherwise be charged for a course in 6 which the student enrolls if: 7 (1) the student has previously enrolled in the same course or a course of substantially the same content and level two 8 9 or more times; and 10 (2) the student's enrollment in the course is not included in the contact hours used in the funding formulas 11 12 established under Section 61.059 for use in making appropriation 13 recommendations for the system. 14 (c) Subsection (b) does not apply to a non-degree-credit 15 developmental course. (d) The total amount of tuition charged to the student under 16 17 Subsection (b) for the repeated course may not exceed the full cost of instruction for the course with respect to the student. 18 19 SECTION 3. The change in law made by this Act applies to a student who, beginning with the 2005-2006 academic year, enrolls 20

for at least the third time in the same or substantially similar courses as described by Sections 130.0034 and 135.52, Education Code, as added by this Act.

SECTION 4. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this
