H.B. No. 1001

A BILL TO BE ENTITLED

AN ACT

1  
2 relating to the compensation of state judges and to the computation  
3 of retirement benefits for members of the elected class of the  
4 Employees Retirement System of Texas.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

6 SECTION 1. Section 659.012, Government Code, is amended by  
7 amending Subsection (a) and adding Subsection (a-1) to read as  
8 follows:

9 (a) Notwithstanding Section 659.011:

10 (1) a judge of a district court is entitled to an  
11 annual salary from the state of at least \$125,000 [~~justice of the~~  
12 ~~supreme court is entitled to an annual salary from the state that is~~  
13 ~~at least \$102,463~~];

14 (2) a justice of a court of appeals other than the  
15 chief justice is entitled to an annual salary from the state that is  
16 equal to 110 percent of the salary of a district judge [~~five percent~~  
17 ~~less than the salary provided by the General Appropriations Act for~~  
18 ~~a justice of the supreme court, except that the combined salary of a~~  
19 ~~justice of the court of appeals other than the chief justice from~~  
20 ~~all state and county sources may not exceed the amount that is~~  
21 ~~\$1,000 less than the salary provided for a justice of the supreme~~  
22 ~~court~~];

23 (3) a justice of the supreme court other than the chief  
24 justice or a judge of the court of criminal appeals other than the

1 presiding judge is entitled to an annual salary from the state that  
2 is equal to 120 percent of the salary of a district judge; and

3 (4) the chief justice or presiding judge of an  
4 appellate [a] court [of appeals] is entitled to an annual salary  
5 from the state that is \$2,500 more than the salary provided for the  
6 other justices or judges of the court [of appeals, except that the  
7 combined salary of the chief justice of a court of appeals may not  
8 exceed the amount that is \$500 less than the salary provided for a  
9 justice of the supreme court; and

10 ~~[(4) a judge of a district court is entitled to an~~  
11 ~~annual salary from the state that is 10 percent less than the salary~~  
12 ~~provided in the General Appropriations Act for a justice of the~~  
13 ~~supreme court, except that unless otherwise provided by law, the~~  
14 ~~combined salary of a district judge from state and county sources~~  
15 ~~may not exceed the amount that is \$2,000 less than the salary~~  
16 ~~provided for a justice of the supreme court].~~

17 (a-1) Subsection (a)(1) applies beginning September 1,  
18 2006. For the fiscal year beginning September 1, 2005, a judge of a  
19 district court is entitled to an annual salary from the state of at  
20 least \$113,350. This subsection expires September 1, 2006.

21 SECTION 2. Section 659.0125, Government Code, is amended to  
22 read as follows:

23 Sec. 659.0125. SALARY FOR LOCAL ADMINISTRATIVE JUDGE. In a  
24 county with more than six district courts, a district judge who  
25 serves as a local administrative district judge under Section  
26 74.091 is entitled to an annual salary from the state that is \$5,000  
27 more than the salary from the state to which the judge is otherwise

1 entitled under Section 659.012 [~~659.012(c)~~].

2 SECTION 3. Section 152.0003, Human Resources Code, is  
3 amended to read as follows:

4 Sec. 152.0003. COMPENSATION. The compensation authorized  
5 under this chapter for a judge serving on a juvenile board is in  
6 addition to all other compensation provided or allowed by law for a  
7 judge. Notwithstanding any other law, the combined salary of a  
8 district judge serving on a juvenile board may not exceed the salary  
9 provided for the chief justice of the supreme court or the presiding  
10 judge of the court of criminal appeals by Section 659.012,  
11 Government Code.

12 SECTION 4. Subchapter C, Chapter 72, Government Code, is  
13 amended by adding Section 72.030 to read as follows:

14 Sec. 72.030. COLLECTION OF DATA RELATING TO JUDICIAL  
15 TURNOVER. (a) The office biennially shall collect data relating  
16 to:

17 (1) the rate at which state judges resign from office  
18 or do not seek reelection; and

19 (2) the reason for action under Subdivision (1).

20 (b) Not later than December 1 of each even-numbered year,  
21 the office shall file a report containing the data collected under  
22 Subsection (a) for the preceding state fiscal biennium with the  
23 lieutenant governor, the speaker of the house of representatives,  
24 and the presiding officers of the standing committees of each house  
25 of the legislature with jurisdiction over the judiciary or  
26 appropriations.

27 SECTION 5. Subchapter H, Chapter 81, Government Code, is

1 amended by adding Section 81.116 to read as follows:

2 Sec. 81.116. COLLECTION OF DATA RELATING TO ATTORNEY  
3 COMPENSATION. (a) The state bar shall biennially collect data  
4 relating to the compensation of lawyers engaged in the private  
5 practice of law.

6 (b) Not later than December 1 of each even-numbered year,  
7 the state bar shall file a report containing the data collected  
8 under Subsection (a) for the preceding state fiscal biennium with  
9 the lieutenant governor, the speaker of the house of  
10 representatives, and the presiding officers of the standing  
11 committees of each house of the legislature with jurisdiction over  
12 the judiciary or appropriations.

13 SECTION 6. Section 814.103, Government Code, is amended to  
14 read as follows:

15 Sec. 814.103. SERVICE RETIREMENT BENEFITS FOR ELECTED CLASS  
16 SERVICE. (a) Except as provided by Subsection (b) and Section  
17 814.1031, the standard service retirement annuity for service  
18 credited in the elected class of membership is an amount equal to  
19 the number of years of service credit in that class, times 2.3 [~~two~~]  
20 percent of the state salary, as adjusted from time to time, being  
21 paid the governor [~~a district judge~~].

22 (b) The standard service retirement annuity for service  
23 credited in the elected class may not exceed at any time 100 percent  
24 of the state salary being paid the governor [~~a district judge~~].

25 SECTION 7. Chapter 814, Government Code, is amended by  
26 adding Section 814.1031 to read as follows:

27 Sec. 814.1031. SERVICE RETIREMENT BENEFITS FOR ELECTED

1 CLASS SERVICE AS STATE PROSECUTOR. (a) In this section, "state  
2 prosecutor" means a person eligible for membership in the elected  
3 class under Section 812.002(a)(3).

4 (b) Except as provided by Subsection (c), the standard  
5 service retirement annuity for service credited in the elected  
6 class of membership paid to a state prosecutor is an amount equal to  
7 the sum of:

8 (1) the number of years of service credit for service  
9 of the member as a state prosecutor times 2.3 percent of the state  
10 salary, as adjusted from time to time, being paid a district judge;  
11 and

12 (2) the number of years of service credit for service  
13 of the member as any other elected class member times 2.3 percent of  
14 the state salary, as adjusted from time to time, being paid the  
15 governor.

16 (c) The standard service retirement annuity paid to a state  
17 prosecutor for service credited in the elected class as a state  
18 prosecutor may not exceed at any time 100 percent of the state  
19 salary being paid a district judge.

20 SECTION 8. Section 133.003, Local Government Code, is  
21 amended to read as follows:

22 Sec. 133.003. CRIMINAL FEES. This chapter applies to the  
23 following criminal fees:

18           SECTION 9. Section 133.004, Local Government Code, is  
19 amended to read as follows:

20           Sec. 133.004. CIVIL FEES. This chapter applies to the  
21 following civil fees:

22           (1) the consolidated fee on filing in district court  
23 imposed under Section 133.151;

24           (2) the filing fee in district court for basic civil  
25 legal services for indigents imposed under Section 133.152;

26           (3) the filing fee in courts other than district court  
27 for basic civil legal services for indigents imposed under Section

1 133.153;

2 (4) the filing fees for the judicial fund imposed in  
3 certain statutory county courts under Section 51.702, Government  
4 Code;

18 SECTION 10. Subchapter C, Chapter 133, Local Government  
19 Code, is amended by adding Section 133.105 to read as follows:

20 Sec. 133.105. FEE FOR JUDICIAL SALARIES. (a) A person  
21 convicted of any offense, other than an offense relating to a  
22 pedestrian or the parking of a motor vehicle, shall pay as a court  
23 cost, in addition to all other costs, a fee of \$2 to fund judicial  
24 salaries.

25 (b) The treasurer shall deposit 10 percent of the fees  
26 collected under this section in the general fund of the county or  
27 municipality for administrative purposes.

1       (c) The treasurer shall remit the remainder of the fees  
2 collected under this section to the comptroller in the manner  
3 provided by Subchapter B.

4       SECTION 11. Subchapter D, Chapter 133, Local Government  
5 Code, is amended by adding Section 133.154 to read as follows:

6       Sec. 133.154. ADDITIONAL FILING FEE IN DISTRICT OR  
7 STATUTORY COUNTY COURT FOR JUDICIAL SALARIES. (a) In addition to  
8 other fees authorized or required by law, the clerk of a district or  
9 statutory county court shall collect a fee of \$35 on the filing of  
10 any civil suit to fund judicial salaries.

11       (b) The treasurer shall deposit 10 percent of the fees  
12 collected under this section in the general fund of the county or  
13 municipality for administrative purposes.

14       (c) The treasurer shall remit the remainder of the fees  
15 collected under this section to the comptroller in the manner  
16 provided by Subchapter B.

17       SECTION 12. Section 101.061, Government Code, is amended to

11 Subchapter A, Chapter 32, Government Code, by this Act, a county may  
12 continue to supplement the salary under the General Appropriations  
13 Act of a judge serving on September 1, 2005, but the combined amount
