A BILL TO BE ENTITLED

1 AN ACT

- 2 relating to the authority of a port authority, a navigation
- 3 district, or certain other persons to use electronically readable
- 4 information derived from a driver's license, commercial driver's
- 5 license, or personal identification certificate for port security
- 6 purposes.
- 7 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 8 SECTION 1. Section 521.126, Transportation Code, is amended
- 9 by amending Subsection (b) and adding Subsections (g) and (h) to
- 10 read as follows:
- 11 (b) Except as provided by <u>Subsections</u> [Subsection] (d),
- 12 <u>(e)</u>, and (g), a person commits an offense if the person:
- 13 (1) accesses or uses electronically readable
- 14 information derived from a driver's license, commercial driver's
- 15 license, or personal identification certificate; or
- 16 (2) compiles or maintains a database of electronically
- 17 readable information derived from driver's licenses, commercial
- 18 driver's licenses, or personal identification certificates.
- 19 (g) If authorized by the executive or administrative head of
- 20 <u>a maritime facility as defined in the Maritime Transportation</u>
- 21 Security Act of 2002 (46 U.S.C. Section 70101 et seq.), or of a
- 22 port, port authority, or navigation district created or operating
- 23 under Section 52, Article III, or Section 59, Article XVI, Texas
- 24 Constitution, a person may access, use, compile, or maintain in a

- 1 database electronically readable information derived from a
- 2 driver's license, commercial driver's license, or personal
- 3 identification certificate to secure the facility or port. The
- 4 information may be used only to:
- 5 (1) identify an individual;
- 6 (2) provide official credentials for an individual;
- 7 (3) track or limit the movement of an individual on
- 8 facility property;
- 9 (4) establish a secure database of visitors to the
- 10 <u>facility;</u>
- 11 (5) access the information at terminal and gate
- operations of the facility; or
- 13 (6) conduct other security or operational activities
- 14 as determined by the executive or administrative head.
- (h) Except as provided by Section 418.183, Government Code,
- 16 the electronically readable information derived from a driver's
- 17 license, commercial driver's license, or personal identification
- 18 certificate for the purposes of Subsection (g) is confidential and
- 19 not subject to disclosure, inspection, or copying under Chapter
- 20 <u>552</u>, Government Code.
- 21 SECTION 2. This Act takes effect immediately if it receives
- 22 a vote of two-thirds of all the members elected to each house, as
- 23 provided by Section 39, Article III, Texas Constitution. If this
- 24 Act does not receive the vote necessary for immediate effect, this
- 25 Act takes effect September 1, 2005.
