

1 AN ACT

2 relating to the filing fee for a candidate for certain offices on
3 the general primary election ballot.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

5 SECTION 1. Section 172.024(a), Election Code, is amended to
6 read as follows:

7 (a) The filing fee for a candidate for nomination in the
8 general primary election is as follows:

4 SECTION 2. The changes in law made by this Act apply only to
5 an election ordered on or after the effective date of this Act.

6 SECTION 3. This Act takes effect September 1, 2005.
