3 (4) if the permit, certified filing, or certificate of 4 adjudication was obtained as the result of the construction of a 5 reservoir funded, in whole or in part, by the holder of the permit, 6 certified filing, or certificate of adjudication as part of the 7 holder's long-term water planning; or

8 (5) to the extent the nonuse resulted from the 9 implementation of water conservation measures under a water 10 conservation plan submitted by the holder of the permit, certified 11 filing, or certificate of adjudication as evidenced by 12 implementation reports submitted by the holder.

13 SECTION 2. This Act applies to a cancellation proceeding 14 that is pending on the effective date of this Act or is initiated on 15 or after the effective date of this Act.

SECTION 3. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this Act takes effect September 1, 2005.
