H.B. No. 1248

A BILL TO BE ENTITLED

1 AN ACT

2 relating to erecting an off-premise sign adjacent to and visible  
3 from certain roads.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

5 SECTION 1. Section 391.252(a), Transportation Code, is  
6 amended to read as follows:

7 (a) A [~~Subsequent to the effective date of this subchapter,~~  
8 ~~a]~~ person may not erect an off-premise sign that is adjacent to and  
9 visible from:

10 (1) U.S. Highway 290 between the western city limits  
11 of the city of Austin and the eastern city limits of the city of  
12 Fredericksburg;

13 (2) State Highway 317 between the northern city limits  
14 of the city of Belton to the southern city limits of the city of  
15 Valley Mills;

16 (3) State Highway 16 between the northern city limits  
17 of the city of Kerrville and Interstate Highway 20;

18 (4) U.S. Highway 77 between State Highway 186 and  
19 State Highway 44;

20 (5) U.S. Highway 281 between:

21 (A) State Highway 186 and Interstate Highway 37;  
22 and

23 (B) the southern boundary line of Comal County  
24 and State Highway 306;

1           (6) State Highway 17 between State Highway 118 and  
2 U.S. Highway 90;

3           (7) State Highway 67 between U.S. Highway 90 and  
4 Farm-to-Market Road 170;

5           (8) Farm-to-Market Road 170 between State Highway 67  
6 and State Highway 118;

7           (9) State Highway 118 between Farm-to-Market Road 170  
8 and State Highway 17;

9           (10) State Highway 105 between the western city limits  
10 of the city of Sour Lake to the eastern city limits of the city of  
11 Cleveland;

12           (11) State Highway 73 between the eastern city limits  
13 of the city of Winnie to the western city limits of the city of Port  
14 Arthur;

15           (12) State Highway 21 between the southern city limits  
16 of the city of College Station and U.S. Highway 290; [~~or~~]

17           (13) a highway located in:

18                   (A) the Sabine National Forest;

19                   (B) the Davy Crockett National Forest; or

20                   (C) the Sam Houston National Forest;

21           (14) State Highway 368 between Interstate Highway 35  
22 and State Loop 410;

23           (15) State Highway 211 between Farm-to-Market Road 471  
24 and State Highway 16; or

25           (16) any segment of one of the following highways in  
26 Bexar County:

27                   (A) State Highway 16;

- 1                    (B) State Highway 81;
- 2                    (C) State Highway 87;
- 3                    (D) State Highway 90;
- 4                    (E) State Highway 281;
- 5                    (F) Interstate Highway 35;
- 6                    (G) Interstate Highway 10; or
- 7                    (H) U.S. Highway 37.

8                    SECTION 2. This Act takes effect September 1, 2005.
