1-9 AN ACT

1-10 relating to erecting an off-premise sign adjacent to and visible
1-11 from certain roads.

1-12 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-13 SECTION 1. Section 391.252(a), Transportation Code, is
1-14 amended to read as follows:

1-15 (a) ~~A [Subsequent to the effective date of this subchapter,~~
1-16 ~~a] person may not erect an off-premise sign that is adjacent to and~~
1-17 ~~visible from:~~

1-18 (1) U.S. Highway 290 between the western city limits
1-19 of the city of Austin and the eastern city limits of the city of
1-20 Fredericksburg;

1-21 (2) State Highway 317 between the northern city limits
1-22 of the city of Belton to the southern city limits of the city of
1-23 Valley Mills;

1-24 (3) State Highway 16 between the northern city limits
1-25 of the city of Kerrville and Interstate Highway 20;

1-26 (4) U.S. Highway 77 between State Highway 186 and
1-27 State Highway 44;

1-28 (5) U.S. Highway 281 between:

1-29 (A) State Highway 186 and Interstate Highway 37;
1-30 and

1-31 (B) the southern boundary line of Comal County
1-32 and State Highway 306;

1-33 (6) State Highway 17 between State Highway 118 and
1-34 U.S. Highway 90;

1-35 (7) State Highway 67 between U.S. Highway 90 and
1-36 Farm-to-Market Road 170;

1-37 (8) Farm-to-Market Road 170 between State Highway 67
1-38 and State Highway 118;

1-39 (9) State Highway 118 between Farm-to-Market Road 170
1-40 and State Highway 17;

1-41 (10) State Highway 105 between the western city limits
1-42 of the city of Sour Lake to the eastern city limits of the city of
1-43 Cleveland;

1-44 (11) State Highway 73 between the eastern city limits
1-45 of the city of Winnie to the western city limits of the city of Port
1-46 Arthur;

1-47 (12) State Highway 21 between the southern city limits
1-48 of the city of College Station and U.S. Highway 290; or

1-49 (13) a highway located in:

1-50 (A) the Sabine National Forest;

1-51 (B) the Davy Crockett National Forest; or

1-52 (C) the Sam Houston National Forest.

1-53 SECTION 2. This Act takes effect September 1, 2005.
