## A BILL TO BE ENTITLED

1	AN ACT

- 2 relating to requiring that a driver's license or personal
- 3 identification certificate issued by the Department of Public
- 4 Safety state whether the holder is a citizen of the United States.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. Section 521.101, Transportation Code, is amended
- 7 by adding Subsection (c-1) to read as follows:
- 8 (c-1) The department shall include on the face of a personal
- 9 <u>identification certificate a statement as to whether the holder is</u>
- 10 a citizen of the United States.
- 11 SECTION 2. Section 521.121(a), Transportation Code, is
- 12 amended to read as follows:
- 13 (a) The driver's license must include:
- 14 (1) a distinguishing number assigned by the department
- 15 to the license holder;
- 16 (2) a color photograph of the entire face of the
- 17 holder;
- 18 (3) the full name, date of birth, and residence
- 19 address of the holder; [and]
- 20 (4) a brief description of the holder; and
- 21 (5) a statement as to whether the holder is a citizen
- 22 of the United States.
- 23 SECTION 3. Section 521.142, Transportation Code, is amended
- 24 by adding Subsections (i) and (j) to read as follows:

- 1 (i) The department shall accept as proof of an applicant's
- 2 <u>United States citizenship any of the following:</u>
- 3 (1) a driver's license or personal identification
- 4 certificate, or a comparable document, issued by an agency or
- 5 department of another state that states on its face that the holder
- 6 of the driver's license, personal identification certificate, or
- 7 <u>comparable document is a United States citizen;</u>
- 8 (2) a legible photocopy of the applicant's birth
- 9 certificate that verifies United States citizenship to the
- 10 <u>satisfaction of the department;</u>
- 11 (3) a valid United States passport issued to the
- 12 applicant or a legible photocopy of the pertinent pages of a valid
- 13 United States passport issued to the applicant that identify the
- 14 applicant and show the passport number;
- 15 (4) the originals of the applicant's United States
- 16 naturalization documents or the number of the certificate of
- 17 naturalization issued to the applicant; or
- 18 <u>(5)</u> any other document or method of proof established
- 19 under the federal Immigration Reform and Control Act of 1986 (Pub.
- 20 L. No. 99-603).
- 21 (j) If under Subsection (i)(4) an applicant provides only
- 22 the number of the applicant's certificate of naturalization, the
- 23 department shall request the United States Citizenship and
- 24 Immigration Services to verify that the certificate of
- 25 <u>naturalization was issued to the applicant.</u> The department may
- issue a driver's license to the applicant only if the United States
- 27 Citizenship and Immigration Services provides the verification.

- 1 SECTION 4. (a) The change in law made by this Act applies
- 2 only to a personal identification certificate or driver's license
- 3 that is applied for on or after September 1, 2005.
- 4 (b) A personal identification certificate or driver's
- 5 license that was applied for before September 1, 2005, is covered by
- 6 the law in effect on the date of the application, and the former law
- 7 is continued in effect for that purpose.
- 8 SECTION 5. This Act takes effect September 1, 2005.
