- 6 SECTION 1. Section 845.115(a), Government Code, is amended
- 7 to read as follows:
- 8 (a) Information contained in records in the custody of the
- 9 retirement system or maintained in the custody of another
- 10 governmental entity or an administrator or carrier acting in
- 11 <u>cooperation with or on behalf of the retirement system</u> concerning
- 12 an individual member, retiree, annuitant, or beneficiary is
- 13 confidential and is not subject to public disclosure under Chapter
- 14 552. The information [under Section 552.101, and] may not be
- disclosed in a form identifiable with a specific individual unless:
- 16 (1) the information is disclosed to:
- 17 (A) the individual or the individual's attorney,
- 18 guardian, executor, administrator, conservator, or other person
- 19 who the director determines is acting in the interest of the
- 20 individual or the individual's estate;
- 21 (B) a spouse or former spouse of the individual
- 22 and the director determines that the information is relevant to the
- 23 spouse's or former spouse's interest in member accounts, benefits,
- or other amounts payable by the retirement system;

- 1 (C) a governmental official or employee and the
- 2 director determines that disclosure of the information requested is
- 3 reasonably necessary to the performance of the duties of the
- 4 official or employee; or
- 5 (D) a person authorized by the individual in
- 6 writing to receive the information; or
- 7 (2) the information is disclosed pursuant to a
- 8 subpoena and the director determines that the individual will have
- 9 a reasonable opportunity to contest the subpoena.
- 10 SECTION 2. This Act takes effect immediately if it receives
- 11 a vote of two-thirds of all the members elected to each house, as
- 12 provided by Section 39, Article III, Texas Constitution. If this
- 13 Act does not receive the vote necessary for immediate effect, this
- 14 Act takes effect September 1, 2005.
