- 5 SECTION 1. Subchapter D, Chapter 508, Government Code, is 6 amended by adding Section 508.1131 to read as follows:
- 7 Sec. 508.1131. SALARY CAREER LADDER FOR PAROLE OFFICERS.
- 8 (a) The executive director shall adopt a salary career ladder for
- 9 parole officers. The salary career ladder must base a parole
- 10 officer's salary on the officer's classification and years of
- 11 service with the department.
- (b) For purposes of the salary schedule, the department
- 13 shall classify all parole officer positions as Parole Officer I,
- 14 Parole Officer II, Parole Officer III, or Parole Officer IV.
- 15 (c) Under the salary career ladder adopted under Subsection
- 16 (a), a parole officer to whom the schedule applies is entitled to
- 17 receive an annual salary according to the following salary
