7	amended by adding Section 1551.067 to read as follows:
8	Sec. 1551.067. CONTRACT RATES FOR PRESCRIPTION DRUGS. The
9	board of trustees shall make available to the public on request the
10	contract rates paid for prescription drugs under the basic coverage
11	plan.
12	SECTION 2. Subchapter C, Chapter 1551, Insurance Code, is
13	amended by adding Section 1551.115 to read as follows:
14	Sec. 1551.115. PARTICIPATION BY CERTAIN INDIVIDUALS
15	EMPLOYED BY SMALL EMPLOYERS. (a) In this section, "small employer"
16	has the meaning assigned by Section 1501.002.
17	(b) An individual who is employed by a small employer may
18	participate in the group benefits program as if the individual were
19	an employee eligible to participate under Section 1551.101. An
20	individual who participates in the group benefits program under
21	this subsection may obtain coverage for the individual's dependents
22	in the manner provided for any other employee.
23	(c) An individual who is employed by a small employer may
24	participate as an employee in that portion of the group benefits

An 1 2 individual who, under this subsection, participates in that portion of the group benefits program that provides only prescription drug 3 4 coverage may obtain coverage for the individual's dependents at the 5 same cost and level of coverage as any other employee. 6 (d) A participant under this section may not receive a state 7 contribution for premiums, and the small employer who employs the 8 participant is responsible for payment of: 9 (1) the contributions the state would make if an individual who participates in the program under Subsection (b) 10 11 were a state employee; and 12 (2) the same percentage of the cost of coverage for an individual who, under Subsection (c), participates in that portion 13 14 of the group benefits program that provides only prescription drug 15 coverage for which the small employer would be responsible under Subdivision (1) if the person participated in the program under 16 17 Subsection (b). (e) The board of trustees shall adopt rules as necessary to 18 19 implement this section. 20 SECTION 3. Subchapter B, Chapter 1601, Insurance Code, is 21 amended by adding Section 1601.064 to read as follows: Sec. 1601.064. CONTRACT RATES FOR PRESCRIPTION DRUGS. A 22 system shall make available to the public on request the contract 23 24 rates paid for prescription drugs under a contract with an 25 administering carrier or a carrier providing coverage under this 26 chapter. SECTION 4. (a) The Employees Retirement System of Texas 27

1 shall develop a plan for the extension of benefits under the group 2 benefits program under Section 1551.115, Insurance Code, as added 3 by this Act. The system may employ persons as necessary to 4 implement this subsection and Section 1551.115.

5 (b) An individual eligible to participate in the group 6 benefits program under Section 1551.115, Insurance Code, as added 7 by this Act, is first eligible to participate on the later of 8 January 1, 2006, or the date that the health benefit plan coverage 9 held by the individual on September 1, 2005, expires or terminates. 10 SECTION 5. This Act takes effect September 1, 2005.
