3 (b) Money collected under Subsection (a) shall be deposited 4 in the county treasury in a special fund to be administered by the 5 county attorney. Expenditures from the fund shall be at the sole 6 discretion of the attorney and may be used only to defray the 7 salaries and expenses of the attorney's office, but in no event may 8 the county attorney supplement his or her own salary from the fund.

9 (b) Sections 284.208(d) and (e), Transportation Code, are 10 repealed.

11 (c) The change in law made by this section applies only to an 12 event of nonpayment of a required toll or charge occurring on or 13 after the effective date of this section. An event of nonpayment of 14 a required toll or charge occurring before the effective date of 15 this section is covered by the law in effect when the event 16 occurred, and the former law is continued in effect for that 17 purpose.

(d) This section takes effect September 1, 2005.

19 SECTION 3. This Act takes effect immediately if it receives 20 a vote of two-thirds of all the members elected to each house, as 21 provided by Section 39, Article III, Texas Constitution. If this 22 Act does not receive the vote necessary for immediate effect, this 23 Act takes effect September 1, 2005.
